BYLAW NO. 12488

A BYLAW to provide special voting opportunities for the
2008 general local election and other voting

WHEREAS section 99 of the *Local Government Act* empowers the Council by
bylaw to provide special voting opportunities for the general voting day;

AND WHEREAS the general voting day for the 2008 general local election is
November 15, 2008;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SPECIAL VOTING OPPORTUNITIES BYLAW 2008.**
