A BYLAW to dedicate certain lands within the City for public parks at Burnaby Fraser Foreshore Park, Burnaby Lake Park, Burnaby 200 Conservation Area, Capitol Hill Conservation Area and Deer Lake Park

WHEREAS section 30 of the *Community Charter* empowers Council, by an affirmative vote of at least 2/3 of all the members of Council, to dedicate for a public purpose real property owned by the City;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY PARK DEDICATION BYLAW 2008.
- 2. There is hereby dedicated for park and recreation uses of the public that real property owned by the City and more particularly described in Schedules A to E inclusive.
