BYLAW NO. 12552

A BYLAW respecting fees charged under the Electrical Bylaw

The Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY ELECTRICAL BYLAW 1974**, **AMENDMENT BYLAW 2008**.
- 2. Appendix "A" of Burnaby Electrical Bylaw 1974 is repealed and the following substituted therefor:

7. Permit Fee to Record Work Done Without Permit and Inspection:

Where electrical work has been carried out without a permit and a permit is accepted to approve and inspect the work after the fact, the fee shall be calculated under section 2 based on the value of the electrical installation as estimated by the Chief Building Inspector at the time of application for the electrical permit (minimum \$109.60)

8. Permit Fee Refund:

Where no work has been performed under the permit, the refund will be 90% of the fee paid subject to a minimum non-refundable of \$100.00. No refunds will be given unless a written request is received by the Chief Building Inspector.
