BYLAW NO. 12583

A BYLAW to close and remove the dedication of certain portions of highway

WHEREAS pursuant to section 40 of the *Community Charter* and section 120 of the *Land Title Act* the Council may by bylaw close part of a highway to traffic and remove the dedication of that part of the highway;

AND WHEREAS the Council, before adopting this Bylaw, has caused the required statutory public notice of its intention to be given by advertisement;

AND WHEREAS the Council deems it expedient and in the public interest to stop up and close to traffic and remove the dedication of those portions of highway more particularly hereinafter described;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- This Bylaw may be cited as BURNABY HIGHWAY CLOSURE BYLAW NO. 1,
 2009.
- 2. ALL AND SINGULAR those certain parcels or tracts of land, situate, lying and being in the City of Burnaby, in the Province of British Columbia, more particularly known and described as all those portions of road in District Lot 25, Group 1, New Westminster District:
 - (a) dedicated as road by Plan 17788 containing 26.9m², and
 - (b) dedicated as road by Plan 17788 containing 74.6m²,

(hereinafter called "the c	losed portions of road") shown outlined and described as Pcl. 1 and Pcl. 2 on
Reference Plan prepared	by Mike E. Shaw, B.C.L.S., and deposited in the Land Title Office under
Number BCP	, a copy of which is hereunto annexed are hereby closed to all types of traffic.

3. The dedication of the closed portions of road as highway is removed.




