
BYLAW NO. 12644


A BYLAW respecting rental fees for Shadbolt Centre
for the Arts and Burnaby Art Gallery

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SHADBOLT CENTRE AND BURNABY ART GALLERY RENTAL FEES BYLAW 2009**.
2. Burnaby Parks, Recreation and Culture Commission may charge for use of facilities at the Shadbolt Centre for the Arts and Burnaby Art Gallery the fees specified in Schedule "A".
3. Burnaby Shadbolt Centre and Art Gallery Rental Fees Bylaw 2008, Bylaw No. 12451 is repealed effective the first day of September, 2009.
4. This Bylaw comes into force on the first day of September, 2009.

SCHEDULE "A"

SHADBOLT CENTRE FOR THE ARTS and BURNABY ART GALLERY

A) PRIVATE RENTALS

Exclusive use by private groups/individuals

<u>Schedule "A"</u>	Weddings, dances, parties, banquets, socials, filming	\$0.0566 / sq.ft./hr.
<u>Schedule "B"</u>	Meetings, conferences, trade shows, rehearsals	\$0.029 / sq.ft./hr.
<u>Schedule "C"</u>	Public performances, recitals a) Indoor theatres b) Outdoor concert bowl	\$2.31/ seat \$6,000 plus 15% of gross ticket sales to max. of \$10,000 Max. rent of \$1.00 / seat
<u>Schedule "D"</u>	Studio public performances, recitals Min. 4 hour rental	\$0.0205 / sq.ft./hr.

B) PRIVATE RENTALS

Rates for groups/individuals booking for extended duration of time.

Outdoor Verandas / Balconies (Bby Art Gallery)	50% of regular rate
10 hour block booking (Schedules "A", "B" only)	80% of regular rate
24 hour block booking (Schedules "A", "B" only)	50% of regular rate
Weekly rental (Sunday - Saturday) (Schedule "C" only / Theatres ONLY)	75% of regular rate
Non-prime space rentals (Studios 105, 106, 211 - Shadbolt Centre) (Studios B, C, D, F, G, H, J - Mathers House)	90% of regular rate

C) PREFERRED RENTALS

Use of facilities by registered non-profit society or City Department.

Registered non-profit society rate (Does not apply to Schedule "A")	65% of private rental rate
City Council Parks, Recreation & Culture Commission Parks, Recreation & Cultural Services Department	No charge
All other City Departments Retirement parties for City employees	35% of private rental rate

D) DAYTIME (Studio) REHEARSALS with Theatre Rental

Daily (max. 8 hrs.)	\$52.48/day
Hourly (min. 2 hrs.)	\$10.50/hr.
Rehearsal Drop-in (Music Studios)	\$ 5.25/hr.

E) ANCILLARY REVENUES

(i.e. sale of merchandise, food, beverage by rental group or organization)

Regular use	15% of gross revenue
Regular use (non-profit society)	10% of gross revenue
Registered non-profit society fundraisers	No charge
