

**CITY OF BURNABY**

**BYLAW NO. 12709**

A BYLAW to exempt from taxation certain lands and improvements pursuant to section 224(1) of the *Community Charter*

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY TAXATION EXEMPTION BYLAW NO. 11, 2009.**
2. Pursuant to section 224(1) of the *Community Charter*, Council does hereby exempt from taxation under section 197(1)(a) of the said Act for the year 2010 the following lands, namely:
  1. The lands used as a park or recreation ground being all that portion of B.C. Electric Railway Company's Right of Way in District Lots 95, 96 and 97, Group 1, New Westminster District, Plan 3961; EXCEPT firstly Parcel 2, District Lot 95, Group 1, Reference Plan 60330 and EXCEPT secondly 735.6 square feet more or less, Reference Plan 7609 and EXCEPT thirdly 0.0998 Acre more or less shown on Plan 22309 and EXCEPT fourthly that portion of the Right of Way lying to the west of the easterly boundary of Buller Avenue (Highland Park Line, Roll No. 9901-0163-0002).
  2. Those lands used as a park or recreation ground being all that portion of Part .284 of an acre more or less of Lot 162, District Lot 92, Plan 1146 as shown red on Statutory Right of Way Plan 10599; Lot 21, District Lot 92, Plan 1318 and Lots 64, 65, 66, 67, 68, 69 and 70, District Lot 95, Plan 1056, Group 1, New Westminster District ( Burnaby Parks, Recreation & Cultural Commission, Roll Nos. 3020-7085, 3020-7086, 3060-7051, 3060-7061, 6895-6617, 6895-6637, 6895-6647, 6895-6667, 6895-6687).

3. The lands used as a park or recreation ground being Lot 107, District Lot 143, Group 1, New Westminster District, Plan 57821 (Forest Grove Park, Roll No.1276-8301-0000).
4. The lands used as a park or recreation ground being Lot 12, District Lot 211, Group 1, New Westminster District, Plan BCP3161 (Richard Bolton Park, Roll No. 8182-9181-0000).
5. The lands used as a park or recreation ground being Parcel One, District Lot 187 and 188, Group 1, New Westminster District, Explanatory Plan LMP562 (Confederation Park, Roll No. 0210-4502-0000)
6. The lands used as a park or recreation ground being all that portion of Parcel "A" (Plan with fee deposited 13274F), District Lot 186, Group 1, New Westminster District (Burnaby Heights Park, Roll No. 0400-3877-0000).
7. The lands used as community office at 8982 University High Street being part of Lot 2, District Lot 211, Group 1, New Westminster District, Plan BCP6258 (Forest Grove Park, Roll No. 0765-8900).
