NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY ZONING BYLAW 1965**, **AMENDMENT BYLAW NO. 46, 2009**.
- 2. Bylaw No. 4742, as amended by Bylaw Nos. 11702, 11927, and 12178, is further amended as follows:


'B' is hereby declared to be and shall form an integral part of said Map 'A', as if originally incorporated therein and shall be interpreted accordingly.


