

**CITY OF BURNABY**

**BYLAW NO. 12752**

A BYLAW to amend Bylaw No. 4231, being the  
Burnaby Sewer Charge Bylaw 1961

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SEWER CHARGE BYLAW 1961, AMENDMENT BYLAW 2009.**

2. Subsections (1) and (1.1) of section 4A of the said Bylaw are repealed and the following substituted therefore:

"(1) The user classified hereunder shall pay for the use of the municipal sewerage system the charge hereinafter specified:

- (a) the owner of any strata lot (not being part of a duplex) shall pay an annual charge of \$217.94 if paid on or before March 15, 2010 or an annual charge of \$229.41 if paid after March 15, 2010;
- (b) the owner of any multiple-family dwelling (except a duplex) used exclusively for residential purposes shall pay for each apartment unit therein an annual charge of \$217.94 if paid on or before March 15, 2010 or an annual charge of \$229.41 if paid after March 15, 2010; and
- (c) the owner of an apartment unit forming part of a duplex shall pay an annual charge of \$101.04 if paid on or before March 15, 2010 or an annual charge of

\$106.36 if paid after March 15, 2010.

(1.1) The charge for a permit to discharge groundwater into the sanitary sewer system from a contaminated site shall be:

\$0.255/m<sup>3</sup> in the Vancouver Sewerage Area

\$0.322/m<sup>3</sup> in the Fraser Sewerage Area."


4. This Bylaw shall come into force on the 1st day of January, 2010.
