#### BYLAW NO. 12999

A BYLAW to dedicate certain lands within the City for public parks at Burnaby Lake Regional Nature Park, Burnaby South Memorial Park, Burrard Inlet Conservation Lands, Confederation Park, Cumberland Place Conservation Lands, Deer Lake Park, New Haven Conservation Lands and Still Creek Conservation Lands

WHEREAS section 30 of the *Community Charter* empowers Council, by an affirmative vote of at least 2/3 of all the members of Council, to dedicate for a public purpose real property owned by the City;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY PARK DEDICATION BYLAW 2011.**
- 2. There is hereby dedicated for park and recreation uses of the public that real property owned by the City and more particularly described in Schedules A to H inclusive.
