under the Powers conferred by section 266 of
Municipal Act 1892 this Council resumes
the amount of the road reservations required by
the N arm road and the extensions of the
Guichon road according to description of
said roads as advertised in the BC

 within the Power of this Council to comply
 with his request

 collector was read this report stated that he
