 that if he does not continue putting
 work on his contract till it is comple-
 ted the contract will be given to
 some one else

To write to the Commissioner of Lows
 thanking him for the work done on
 the Hastings road through the
 Hastings Townsite and requesting
 him to join with this municipality
 in having a portion of the North road
 repaired the portion of the North road
 referred to is the part between lots 101 & 102
 & 31 in Dumnaby District and lots 54-104
 103 & 26 Crown lands
