and suggests that the bridge be closed for time
and a way made round that will supply

be authorized to draw up Specifications
and let a Contract for new Sills to
the Woollard bridge on the North
Arm road

That the Reeve be requested to commu-
-nicate with Rand Bros personally or by
letter in the matter of right of way
being granted by the land owners interested
for the extension of the Royal Oak road

That Councillors Slides & Cradock
see about a new short road between
the Tramway track and the Royal Oak road

That Mr Hargrave be instructed to
prepare Specifications for bridging
the third Ravine down the
North Arm road

A Communication from Mr Wm Bailey
was read and it was resolved that owing
chiefly to lack of funds the services of
any Constable be dispensed with until
needed

That Councillors Cliff Spott & Ledger
be a Committee to inspect ditch on
4th Avenue

That the Council Adjourn until
Saturday 24 inst at 2 p.m.
