

NOV 4 1899

The Council met on Saturday 4 Nov 1899  
at 2.30 pm in Municipal Hall

Present Reeve Schou in the Chair and  
Councillors Cliff, Smith, Stride & Spratt.

It was moved & seconded by Counc. Cliff  
& Stride and resolved that in the absence  
of the Clerk, that Mr. Thasgard, the Collector  
act in that capacity, and sign cheques  
for amounts paid out this day by the Council.

The minutes of last Meeting were read &  
were on motion adopted.

The Collector presented a statement of the  
results of Tax Sales.

It was moved & seconded by Counc. Cliff  
& Smith and resolved that the Government  
be asked whether they will sell some of the  
Govt. Land in Butnaby to actual settlers.

It was moved & seconded by Counc.  
Cliff & Smith & resolved that a road  
to connect with Mr. H. Lewis' road be  
made between the largest stumps, to allow  
Mr. Wente's access to his property on Lot 89  
and that said road be 12 ft wide and  
about 10 chains long.

A communication was read from Contractor  
on Boundary Road, asking permission to use  
sawdust instead of earth as covering for  
roadway. The Clerk was instructed to reply

that the terms of the Contract must be strictly complied with.

It was moved & seconded by Couns. Cliff & Sprout & resolved that 50 yards of gravel be spread on Edmonds Rd. and 150 yards on Hastings Rd. in each case where shown & that Couns. Cliff Stride & Sprout be a committee for obtaining & awarding contracts for the performance of the work.

It was moved & seconded by Couns. Smith & Cliff & resolved that Coun. Stride be appointed a committee of one, to confer with W<sup>m</sup> Campbell of the B. C. E. Tramway Co re gravelling track and to report at next meeting.

The Collector asked that his office time be reduced to one day a week for the rest of the year. on motion the request was granted, & the Collector was requested to attend on Monday in each week. Notification to be given to the public by advertisements in Weekly Columbian & Daily World.
