

FEB 17 1900

The Council met on Saturday, 17th Febry
1900, in Municipal Hall at 3 pm.

The Reeve being absent through
indisposition, Council: Byrne was, on
motion, appointed Chairman, all the
Councillors being present.

The Minutes of last meeting were read,
and were, on motion, adopted.

The Chairman, reported, re Bridge on
Tooth Arm Road, partly demolished by
a falling tree, that after consultation
with the other Councillors, he had drawn
up a specification, and had called
for tenders for repairing same, and
the following tenders had been received:-
J. Throssell for 60⁰⁰/₁₀₀ + 12⁰⁰/₁₀₀ p. 1000 for all new
lumber used:

F. M. Eddy + A. R. Dean for \$125⁰⁰ and 13⁰⁰ per 1000
 for new lumber used.

And had let the contract to the lowest
 tenderer W. J. Throssell. on motion
 the report was received and the contract
 approved.

The Auditor's report laid over from last
 meeting was considered, and was on motion,
 ordered to be received, and the necessary
 number of copies ordered to be printed for
 circulation.

A report was read from Dr. R. E. Wacker,
 stating that he had visited the sick man
 Chesley and found him dangerously ill.
 on motion it was resolved to make him a
 monthly allowance of Eight Dollars,
 until it became necessary to remove him
 to the hospital.

A communication was read from Revere School,
 enclosing a letter received by him from
 W. Thos. Studd M.P. re requested grant
 towards trunk road. Received & filed.

A communication was read from E. Jones,
 and was on motion laid over till next meeting.

A communication was read from Maple
 Ridge Municipal Council, asking this
 Council to endorse a resolution protesting
 against the Govt. making a grant towards
 the Lander trunk road. on motion it was resolved
 that the Council regrets that the request cannot be
 granted.

An account was read from Aquilham Council for share of work on North Road, and was on motion laid over till next meeting, same being pay day.

The Clerk was instructed to obtain from the Corporation Solicitors their opinion as to ownership of timber on gazetted road reservations.

The Meeting adjourned to meet on Saturday 3rd March at 7.30 p.m.
