

Tuesday - January 2nd. 1912.

An Adjourmed Meeting of the Council was held on Tuesday, January 2nd. inst. at 11 O'clock a.m.

Present: - His worship Reeve Weast in the Chair.

Councillors Coldicutt, Rumble, Stride, Mr. Gregor and Mr. Kee.

Correspondence was received and dealt with as follows:- viz.

1. Upper Larchipin - Claim against A. B. Beoloff for damages by blasting to the poles & equipment of the Western Canada Power Co. at Johnston Road.
Moved by Cr. Rumble, Seconded by Cr. Mr. Gregor: - "That the matter be referred to the Engineer & Wiring Inspector to investigate and report."

Carried unanimously.

2. W. J.am. Hamilton - Offer to sell to Burnaby one acre adjoining Reservoir Site in D.L. 189. viz. Lot 1. Blk. 8. S.D.L. 189.
Moved by Cr. Mr. Gregor, Seconded by Cr. Rumble: - "That Mr. Hamilton be informed that this Corporation do not require the property specified, and the letter be filed."

3. Solicitor - re. Cariboo Rd. Bush Fire (Chas Granholm Contract)
Moved by Cr. Mr. Gregor. Seconded by Cr. Stride: - "That the matter be 'Tabled'." Carried unanimously.

4. R. C. MacTeill - Application for loan \$800.
Moved by Cr. Coldicutt, Seconded by Cr. Stride: - "That this application be referred to the incoming Council." Carried unanimously.

5. Locwen Harvey & Hubble Ltd. - Offer to sell to Burnaby D.L. 89 for School & Park purposes.
Moved by Cr. Coldicutt, Seconded by Cr. Stride: - "That this matter be referred to the incoming Council." Carried unanimously.

6. C. Rummel, B.C.H. Ry. re. Street Lights.
Moved by Cr. Mr. Kee, Seconded by Cr. Rumble: - "That the letter be received and filed." Carried unanimously.

7. Vancouver World - Asking to be furnished with a mailing list for the "Publicity" issue.
Moved by Cr. Coldicutt - Seconded by Cr. Stride: - "That the Clerk prepare a list, including addresses of towns with Free Libraries in Great Britain." Carried unanimously.

8. Solicitors - re. Arbitrator for Highway Appropriation By Law.

Claude Hill, repeating inability to act as Arbitrator for Highway

Moved by Cr. Coldicutt, Seconded by Cr. Rumble:- "That Mr H. A. Eastman be appointed Arbitrator to act for Burnaby under the Highways Expropriation By Law."

Carried unanimously.

1. Burnaby School Board - "Thanking Council for offer of Office accommodation in the new Municipal Hall, and intimating that as the Contract had been let for School Board Offices, the Board were unable to avail themselves of the offer."

Moved by Cr. Mc Gregor, Seconded by Cr. Stride:- "That the letter be received and filed."

2. Lambert Bond - Repetition inability to attend meeting of Council with reference to diversion of Road in D.L. 145.

Moved by Cr. Mc Gregor, Seconded by Cr. Stride:- "That Mr Bond be notified that the Council will be pleased to confer with him on this matter, at his convenience."

3. Moved by Cr. Coldicutt, Seconded by Cr. Stride:- "That the Architects, Messrs. Somervell & Putnam, be notified that there are several minor matters, as well as the more important matter of leaks in the roof, in connection with the contract for the Municipal Hall; which need attention, and that no final certificate is to be issued until everything is satisfactorily completed."
