Councillors Richmond, Webb, Ward, McElpnew, and Murray:

Moved by Cr. McElpnew, Seconded by Cr. Webb: - That the Minutes of the Meeting of February 18th. ult., be adopted and confirmed.

Carried unanimously.

Moved by the Reeve, Seconded by Cr. Webb: - That a letter be sent to the bereaved family of the late Premier, expressing the sincere sympathy and condolence, and also the sense of loss experienced by the people of this Municipality.

Carried unanimously.

By a Standing Vote.

An Order from the County Court of New Westminster, was received, declaring the Election of P. W. Faulstich as Councillor for Ward 4 to be void, and ordering a new election to be held, Nominations to be received on March 14th, and if necessary, the Poll to be taken on March. 9th., with Arthur G. Moore as Returning Officer.

2 Your Committee met on February 25th. 1918, and

7 reports of Messrs. Hermon & Laverock, and the Works Superintendent
8 with reference to the North Road Bridge; to the Board of
9 Railway Commissioners, and to the Solicitor for the C.N.Ry.
10 Company.
11 3. That sundry applications for improvements be referred to
12 the Works Superintendent, to report.
13 4. That the necessary materials be provided for replacing the
14 loose drain through Lot 13, Block 24, D.S. 24; and the offer
15 of Mr. Kolb to supply labour, be accepted.
16 5. That the Wages of Foremen be \$5.45 per. day, straight time,
17 in accordance with the understanding in the matter of
18 Saturday half holidays, and emergency work, as
19 outlined by Foremen Ettinger and Warne.

20 Moved from the Chair, Seconded by Mr. Webb:- "That the Report

23 Moved by Mr. Webb, Seconded by Mr. Murray:- "That this Council
24 do now resolve into a Committee of the Whole, with the Reeve
25 in the Chair, to reconsider the Bernaldy Main Roads By Law,
26 1918."

27 Carried unanimously.

28 Moved by Mr. Murray, Seconded by Mr. Mulpew:- "That the
29 Committee do now rise and report the By Law complete,
30 without amendment".

31 Carried unanimously.

32 The Council re-convened.

33 Moved by Mr. Webb, Seconded by Mr. Ward:- "That the Bernaldy
34 Main Roads By Law, 1918, be read a Third time."

35 Carried unanimously.

36 Moved by Mr. Webb, Seconded by Mr. Ward:- "That the Bernaldy
37 Main Roads By Law, 1918, do pass the Third Reading, that it
38 be signed by the Reeve, and the Clerk, and that the
39 Corporate Seal be affixed thereto."

40 Carried unanimously.

41 Moved by Mr. Webb, Seconded by Mr. Murray:- "That the congratulations
42 and appreciation of this Council be conveyed to Private A. J. Christ
43 in recognition of the decoration conferred upon him, for valor

1 at Viny, of the Russian decoration of the Cross of St. George."

2 Carried unanimously.

3 Moved by Mr. Murray, Seconded by Mr. Mulpew:- "That Messrs.

4 Hermon and Lawrook be instructed to inspect and to report
5 on the new road constructed by the G. V. Ry. Co., south from
6 the new bridge to the Brunette River."

7 Carried unanimously.

8 Mr. G. A. Skinner attended and addressed the Council upon
9 the subject of Motor-truck service, and the purchase of Feed.

10 Considerable discussion ensued, and it was finally understood
11 that the matter would be left for Councilor Mulpew to secure
12 certain data.
