

Monday - December 22nd. 1919.

A Regular Meeting of the Council was held at the Municipal Hall on Monday - December 22nd. 1919, at 8.15 p.m.

Present:- His Worship Reeve Sanderson.

Councillors Richmond, Edgar, Lawson and Russell.

Moved by Cr. Lawson, Seconded by Cr. Edgar:- "That the Minutes of the Meeting of December 8th. inst., be adopted as written, and confirmed."

Carried unanimously.

Correspondence was received and dealt with, as follows:-

1. J. S. Jamieson re. Cancellation of the Plan of Block 15, D. L. 53.
Moved by Cr. Edgar, Seconded by Cr. Lawson:- "That the letter be received and filed."

Carried unanimously.

2. W. G. Mc. Cranie, M. P. re. Postal Delivery Areas, enclosing copies of letters from the Postmaster General and the Superintendent of Post Offices.

Moved by Cr. Russell, Seconded by Cr. Edgar:- "That the letters be received and filed."

Carried unanimously.

3. Solicitors re. Island Investment Co. and Special Survey, advising that they had informed the applicants that their claim could not at present be entertained.

Moved by Cr. Edgar, Seconded by Cr. Lawson:- "That the letter be received and filed."

Carried unanimously.

Moved by Mr. Lawson, Seconded by Mr. Edgar: - "That a Committee wait upon the District Engineer with reference to this matter and also as to Riverway D. L. 142".

Carried unanimously.

Moved by Mr. Russell, Seconded by Mr. Edgar: - "That the Report of the Water Committee be adopted."

Carried unanimously.

3. Board of Works Report: -

Your Committee met on December 15th. 1919. and recommend:-

1. That the Estimate of Work for the two weeks commencing December 22nd., amounting to \$355., be adopted.
2. That the Contingent Expenditure for the period ending December 15th., amounting to \$94.84, be approved.
3. That the Council go on record as being favourable to the settlement scheme in reference to D.L. 41 and 42, as outlined by Mr. Howard; and that it is proposed to endorse any proposal which may be for the benefit of returned soldiers, or provide for increased production.
4. That a crossing be put in on Tragalgar Street, subject to the usual terms.
5. That empty applications for improvements be referred to the 1920 Council.

Moved by Cr. Edgar, Seconded by Cr. Lawson: - "That the Report of the Board of Works be adopted."

Carried unanimously.

1. Property Committee Report:-

Your Committee met on December 8th. 1919. and recommend:-

1. That the penalty in respect of the re-purchase of D.L. 48 by Mr Greenhow, be reduced from \$25 to \$10 per acre.
2. That Lots 1 and 2, Block 5, D.L. 186, be sold to Frederick Monk, for the sum of \$500.
3. That Lot 1, R. & D. 6, S.D. 10, Block 2, D.L. 158 be sold to F. A. Johnson, together with the building thereon, for the sum of \$100.

Moved by Cr. Edgar, Seconded by Cr. Richmond: - "That the Report of the Property Committee be adopted."

2. Light and Power Committee Report:-

Your Committee met on December 15th. 1919. and recommend:-

1. That the Pole Location for the Street Light at Fir and Macdonald, be along the south side of Fir Street (10' from the property line) to Inman Ave., thence diagonally to the north side of Fir Street (8' from the property line) to the location at Macdonald.

Moved by Cr. Richmond, Seconded by Cr. Edgar:—"That the Report of the Light and Power Committee be adopted".

Carried unanimously.

2. Mr. Klueber attended and addressed the Council with reference to repairs on 14th Avenue.

Moved by Cr. Edgar, Seconded by Cr. Lawson:—"That this matter be referred to Cr. Richmond to see what can be done, and to report to the Board of Works".

Carried unanimously.

3. Councillor Edgar asked if a Referendum, re. Housing Scheme, would be submitted at the forthcoming elections.

The Reeve suggested that this matter be deferred until Monday next, in order to ascertain whether the allotment is still available.

4. Councillor Russell asked if it was proposed to submit a By Law for Waterworks purposes at the forthcoming elections.

The Reeve advised that necessary data be obtained before discussing this matter further.

5. The Reeve, on behalf of this Council, tendered to Mr. G. L. Cassady of the firm of Corporation Solicitors, who was present; congratulations upon the award to him of the Distinguished Service Cross.

6. The Reeve referred to a certain letter which appeared in the Columbian newspaper of the 16th inst. and corrected certain statements therein.

7. Moved by Cr. Russell, Seconded by Cr. Richmond:—"That a photograph of Cr. Reeve H. M. Fraser be obtained for the purpose of having the same enlarged and framed, and hung in the Council chamber".

Carried unanimously.

Moved by Cr. Edgar, Seconded by Cr. Russell:—"That this Council do now adjourn until Monday, December 29th. inst."
