

Monday, May 5th. 1919.

An Adjourned Meeting of the Council was held at the Municipal Hall on Monday, May 5th. 1919, at 8 O'clock. p. m.

Present:— Councillors. Richmond, Webb, Ward, Edgar, Lawson and Russell.

His worship the Reeve was absent on account of sickness.

Moved by Mr. Webb, Seconded by Mr. Richmond:— "That Councillor Lawson do take the Chair as Acting- Reeve."

Carried unanimously.

Moved by Mr. Webb, Seconded by Mr. Russell:— "That this Council do now resolve into a Committee of the Whole, with the Acting- Reeve in the Chair, to reconsider the Bymaley Percentage Additions By Law, 1919."

Carried unanimously.

Moved by Mr. Webb, Seconded by Mr. Russell:— "That Section one be amended by striking out all the words after 1. and substituting the following therefor:— "Upon the first day of August, 1919, the Collector shall add to the current year's taxes unpaid on each parcel of land or improvements upon his roll, five per. centum of the amount thereof, and upon the first day of October, 1919, shall add an additional amount of five per. centum thereof, and upon the first day of December, 1919, he shall add a further additional amount of five per centum thereof; and the said unpaid taxes, together with the amounts added as aforesaid, shall from the respective dates aforesaid, be deemed to be the amount of current year's taxes due upon said land and improvements."
