

Monday - January 26th. 1920.

An Adjourned Meeting of the Council was held at the Municipal Hall on Monday, January 26th. 1920, at 10 O'clock. a. m.

Present:- Councillors McLean, Keilly, Rummel, White, Lawson, and Russell.

His worship the Reeve was absent on account of sickness.

1. Moved by Mr. Russell - Seconded by Mr. McLean:- "That Mr. Lawson do take the Chair as Acting-Reeve."

Carried unanimously.
