

Wednesday - March 3rd, 1920.

An Adjourned Meeting of the Council was held at the Municipal Hall on Wednesday, March 3rd, 1920, at 2.15 O'clock. p.m.

1. Moved by Mr. Sean, Seconded by Mr. Heilly: "That this Council do now resolve into a Committee of the Whole, with the Acting-Reeve in the Chair, to consider the Estimates for the current year." Carried unanimously.

Moved by Mr. Sean, Seconded by Mr. Rummel: "That the item 'Fixed Charges', \$201,494.60. - pass." Carried unanimously.

Moved by Mr. Sean, Seconded by Mr. Rummel: "That the item 'School Board Estimates' - \$86,559.51 - pass." Carried unanimously.

Moved by Mr. Rummel, Seconded by Mr. Sean: "That the item 'Election Expenses', be reduced to \$450.00." Carried unanimously.

Moved by Mr. Rummel, Seconded by Mr. Sean: "That the item 'Voters Lists', be reduced to \$600.00." Carried unanimously.
