

Monday, June 4th, 1920.

A Regular Meeting of the Council was held at the Municipal Hall on Monday, June 4th, 1920, at 7.30 p.m.

Present: - His worship Reeve Sanderson.

Councillors McLean, Coldicutt, Rummel, White, Lawson, and Russell.

Moved by Mr. Russell, Seconded by Mr. McLean: - "That the Minutes of the Meeting of May 25th. ult. be adopted as written, and confirmed."

Carried unanimously.

Correspondence was received and dealt with, as follows: -

1. Mr. Quarie, Martin & Co. - Notice of Cancellation of the Sub-division Plan of Block 24, D. L. 55.

Moved by Mr. Coldicutt, Seconded by Mr. Rummel: - "That no objection be entered by this Council, herein."

Carried unanimously.

2. Public Works Engineer re. Change in Rule of the Road.

Moved by Mr. Coldicutt, Seconded by Mr. Lawson: - "That the letter be received and filed, and that copies of the map be procured for the members of the Council."

Carried unanimously.

3. Secretary, Vancouver Harbours Commission re. Dam at Second Narrows - Burrard Inlet, asking for the official views of this Council thereon.

Moved by Mr. Russell, Seconded by Mr. McLean: - "That the letter be received and filed."

An Amendment was

Moved by Mr. Coldicutt, Seconded by Mr. Lawson: - "That the writer be advised that Burraby is greatly interested in the project, and has no objections to offer, as such works as proposed would benefit all parties concerned. This Corporation, however, is of the opinion that the cost of the proposed works should be borne entirely by the Federal Government, and also desires to go on record as not being in a position to contribute any part of the cost of such works, either at the present or any future time."

On the Amendment being put,

Councillors Coldicutt, Lawson, Rummel and White, voted in favour, and

Councillors Russell and McLean voted against.

8. Geo. Green, re. Sub. division Plan of D. L. 135 - asking that a part of Kitchener Street be planed.

9. Solicitor re. Maps Approval By Law, advising the provisions under which this By Law was passed, has been repealed.

4. Mr. C. Gray resubmitted the Sub-division Plan of part of D.L. 45.

Moved by Mr. Coldicutt, Seconded by Mr. Summel: - "That this Plan be referred to the Engineer to report at the next meeting of the Board of Works, giving in such report, full details as to the physical features of the property."

Carried unanimously.

5. The Chairman of the Property Committee submitted a recommendation that no commission be paid to any broker in respect of the sale of Municipal lands unless and until such broker shall have held a license from Burnaby for a period of at least 30 days prior to the date of a sale.

Moved by Mr. White, Seconded by Mr. Lawson: - "That the recommendation be adopted."

Carried unanimously.

6. Mr. A. Lomas attended and addressed the Council with reference to the enforcement of the License in respect of non-resident brokers.

7. W. H. West, Steam Roller Engineer, attended and addressed the Council with reference to his claim for wages for January and part of February of the current year.

Moved by Mr. Coldicutt, Seconded by Mr. McLean: - "That this be referred to the Finance Committee."

Carried unanimously.

1. Cr. Coldicutt reported verbally re. Municipal Ball, and also re. Bazaar Exhibit at the forthcoming Provincial Exhibition.
It was agreed that a Meeting be called for Tuesday, June 15th. inst. with reference to both matters.

2. Cr. McLean referred to the matter of the disposal of the Edmonds Block.
Moved by Cr. Coldicutt, Seconded by Cr. McLean:—"That this be referred to the Clerk, with full power to act."
Carried unanimously.

3. Cr. McLean referred to the matter of the "Rumble" mortgage
Moved by Cr. Coldicutt, Seconded by Cr. Rummel:—"That Mrs Rumble be notified that the Council have again considered this matter, and invite her to meet the Finance Committee privately on Monday next; also advising that failing any definite arrangement being reached, action to recover, must be taken by this Corporation."
Carried unanimously.
Moved by Cr. Lawson, Seconded by Cr. White:—"That this Council do now adjourn until Monday, June 14th. inst."
Carried unanimously.
