Moved by Mr. Russell, Seconded by Mr. Edgar: - "That the Minutes of the Meeting of January 8th. inst., be adopted as written, and confirmed.

For - 904. Against - 444.

Three-fifths required = 818.

For - 808. Against - 518.

Three-fifths required = 495.
