

Tuesday, November 7th, 1922.

A Regular Meeting of the Council was held at the Municipal Hall on Tuesday, November 7th, 1922, at 7.30 p.m.

Present:- His worship Reeve McLean.

Councillors Yoney, Gairin, Rummel, Edgar, Lawson, and Russell.

Moved by Mr. Edgar, Seconded by Mr. Lawson:- "That the Minutes of the Meeting of October 23rd. ult. be adopted as written, and confirmed.

Carried unanimously.

Correspondence was received and dealt with, as follows:-

1. Secretary, School Board, re. Election of Trustees.

Moved by Mr. Russell, Seconded by Mr. Yoney:- "That the letter be received and filed.

Carried unanimously.

2. Corporation Solicitors - re. Firearms, advising that the Council has power to pass a By-Law to prohibit the firing of guns or other firearms, within any possessed areas in the Municipality.

Moved by Mr. Russell, Seconded by Mr. Edgar:- "That the letter be received and filed.

Carried unanimously.

3. J. H. Barber, re. Trades Licenses to Orientals, expressing appreciation at the action of this Council herein.

Moved by Mr. Edgar, Seconded by Mr. Lawson:- "That the letter be received and filed.

4. Mayor of New Westminster, - Invitation to attend the unveiling of the Citizen's Memorial on Armistice Day.

The Special Committee reported that the Royal Columbian Hospital and the Vancouver General Hospital have agreed in consideration of the payment to each, of the sum of \$2595.58, and in addition the payment to them on a 50-50 basis, of the 50% of the liquor profits accruing to this Municipality to December 31st, 1922; to release this Corporation from all claims accrued or accruing to December 31st, 1922. The Committee further recommended that the Municipal Treasurer be authorized to forthwith disburse the 50% of the share of liquor profits now in hand, in accordance with the provisions of the Order-in-Council approving such distribution.
