Moved by Cr. Hall, Seconded by Cr. Smith: "That the recommendation of the special committee be adopted."

Carried unanimously.

His Worship the Reeve submitted a request that a special committee be formed to interview the various interests concerned in the proposed amalgamation of the New Westminster and Vancouver Annual Fairs.

Moved by Cr. Gibbs, Seconded by Cr. Hall: "That His Worship the Reeve, Councillor Smith and Councillor Engberg be the committee."

Carried unanimously.

Mr. F.H.Mabbutt applied for permission to erect a dwelling on Pandora Street in the 3800 block at a less distance from the street line than called for in the Burnaby Town Planning By-law No.1. owing to present houses being closer than prescribed in the by-law.

Moved by Cr. Gibbs, Seconded by Cr. Smith: "That permission be granted to F.H. Mabbutt to erect a dwelling on Lot 4, Block 2, D.L.116/186 in line with other dwellings already erected on the street. "

Carried unAnimously.

His Worship the Reeve requested authority to proceed to Victoria on Tuesday October 6th inst. in company with Mayor Taylor and Mayor Annandale to interview the Minister of Public Works re the proposed new highway.

Moved by Cr. Smith, Seconded by Cr. Engberg: "That the Reeve be authorised to so proceed."
