

Monday - May 27th. 1929.

An adjourned meeting of the Council was held at the Municipal Hall on Monday, May 27th. 1929 at 7.30 o'clock p.m.

Present: His Worship Reeve Burdick in the chair.

Councillors West, Rylett, Lambert, Pritchard, Wheatley and Wilson.

Cr. Shewbrooks absence on leave.

Moved by Cr. West, Seconded by Cr. Pritchard: "That this Council do now resolve into a Committee of the whole with the Reeve in the chair to reconsider the Burnaby Waterworks Regulation By-law No. 2. 1926 Amendment By-law No. 2. 1929."

Carried unanimously.

Moved by Cr. West, Seconded by Cr. Lambert: "That the Committee do now rise and report the By-law complete without amendment."

Carried unanimously.

The Council re-convened.

Moved by Cr. West, Seconded by Cr. Wheatley: "That the Burnaby Waterworks Regulation By-law No. 2. 1926 Amendment By-law No. 2. 1929 be now read a Third time."

Carried unanimously.

Moved by Cr. Pritchard, Seconded by Cr. Rylett: "That the Land Acquisition Committee be re-constituted consisting of Cr. Wilson, the Engineer, Clerk and Treasurer."

Carried unanimously.

Cr. Pritchard requested that matter of work being done on Imperial St. from Nelson Avenue to Royal Oak Avenue under the Burnaby Roads

Improvement By-law 1928 be referred to the Clerk and Treasurer for report. His Worship so declared.

The Council then adjourned.
