Correspondence was received and dealt with as follows:

Secretary, Central Park Local Committee - requesting information as to the present status of the Committee, and if the Commissioner be desirous of having the Committee continue expressing the desire for a meeting with the Commissioner: Ordered: "That the letter be received and the Committee be advised that it is the wish of the Commissioner that the Committee continue to function and that he will be pleased to confer with the Committee from time to time as the occasion may arise."

Secretary, Central Park Local Committee - requesting that all cutting of alder wood be probibited in Central Park for the time being. Ordered: That the letter be received and filed and the suggestion of the Committee be approved.

Secretary, Rurnaby Town Planning Commission - requesting that the cutting of any further alder wood from Central Park be prohibited meantime and that signs be erected in other parks in the Municipality prohibiting the cutting of wood therefrom.

Ordered: "That the letter be received and the suggestion of the Commission be adopted in principle."

Secretary. Rurnaby Town Flanning Commission - requesting that the Commissioner memorialize the Union of B.C. Municipalities in matter of securing amendments to the Municipal Act to enable Municipal Corporations to set "set back lines" for buildings on certain streets and to clarify the position of such Municipalities in the matter of paying compensation to owners affected.

Ordered: "That the letter be received and filed and the suggestion to approved."

Russell Russell & DuMoulin - advising that they had been instructed by the Greater Vancouver Water District to take the necessary actionto recover or protect its claims against the Corporation of the District of Burnaby for water surplied and for money due and rayable under anagreement dated January 22nd.1951 covering cost of enlarging the steel main on the Municipality's account.

Ordered: "That the letter be received and be referred to the Corporation Solicitor for report."

<u>Hussell</u> Russell & DuMoulin - advising that they had been instructed by the Vancouver and DES tricts Joint Sewerage and Drainage Board to take the necessary action to recover or protect the claim of the Board against the Municipality. The amount of the claim being \$51,775.16 Ordered: "That the letter be received and be referred to the Corporation Solicitors for report."

<u>Mrs.I.Norum</u> - Sec. <u>East Burnaby Branch</u> - Womens Labour League - requesting hearing for a delegation ordered: "That the letter be received and the delegation be heard at the conclusion of this sitting."

Mesers W.G.McQuerrie & Co. - forwarding copy of letter received from Supt. of Welfare re Mrs.P.L.Passenger in which the Superintendent advised that if the Corporation was of opinion that the case was one for which the Corporation was not liable appeal would have to be made to the Inspector of Municipalities for his decision.

Ordered: "That the letter be received and the Solecitors be instructed to take the matter up further with the Provincial Government."

General accounts \$1,503.32; Relief Accounts \$13,400.47; Pay Rolls \$2,109.28 Mileage accounts \$39.25 and Land Sale commissions \$1.25 were examined. Ordered: "That this accounts be approved for rayment as and when funds are awailable."

The Chief Constable submitted Annual report on Fire situation showing that the Department handled 106 calls with a mileage of 256.9 miles. Ordered: "That the report be received and filed."

The Deputy Municipal Engineer submitted a recommendation that Mr.H.Palethorpe be granted permission to erect a pole line on Eurford Street in accordance with plan submitted. Ordered: "That the recommendation of the Deputy Engineer be adopted."

Ordered: "That the Committee do now rise and report the by-law complete without amendment." amendment."
Ordered: "That the Burnaby Property Exchange By-law No.1.1933 be now read a Third time."
Ordered: "That the Burnaby Property Exchange By-law No.1,1933 do pass the Third reading, that it be signed by the Commissioner and the Clerk and that the Corporate seal be affixed thereto."

Orderea: "That the Taylor Property Sale By-law 1933 be introduced and read a first time." . . Ordered: "That the Taylor Property Sale By-law 1955 do pass the first reading." Ordered: "That the Taylor Property Sale By-law 1933 be now read a second time." Ordered: "That the Taylor Property Sale By-law 1933 do passthe secondreading."

The sitting then adjourned.
