

Thursday, May 25th, 1933.

A Regular sitting of the Commissioner was held at the Municipal Hall, on Thursday, May 25th, 1933, at 10 o'clock a.m.

Present: Commissioner Bennett and the Municipal Clerk,

Ordered that the minutes of the meeting of May 17th. be adopted as written and confirmed.

Correspondence were received and dealt with as follows:

1. Childrens Aid Society wrote enclosing commitment and maintenance order of Jean Riley. & orders
Resolved:- "That this letter be received and filed."
2. Childrens Aid Society wrote enclosing commitment and maintenance order of Gordon Cooch.
Resolved:- "That this letter, and orders be received and filed."
3. Ocean View Development Limited wrote asking if it would be possible to complete the construction of a cement concrete sidewalk on Imperial Street.
Resolved:- "That this letter be received, and that the Ocean View Development Ltd. be advised that this Municipality is not in a position to carry out this work at the present time."
4. Department of Public Works wrote advising that owing to curtailment of funds work on Riverway, and North Road must not exceed the sum of \$400.00 for the fiscal year 1933-34.
Resolved:- "That this letter be received and filed."
5. Department of Public Works wrote advising that they proposed to spend \$3,000. on the Grandview-Douglas Highway during the fiscal year 1933-34 and asking if this Corporation is prepared to meet its share of 25%.
Resolved:- "That this letter be received, and that the Department be advised that provision has been made for the Corporation's share of the cost"
6. *to be taken up at 10:30*
The Treasurer submitted a recommendation that the sum of \$5.48 on Lot 6, and \$5.89 on Lot 7, being the amount of the penalty and interest charges on the 1931 taxes, be rebated under Section 274 of the Municipal Act.
Resolved:- "That the recommendation of the Treasurer be approved."
7. The Treasurer submitted report recommending that Tax Sale Certificate to Lot 5, Blk. 3, D.L. 162 be sold to Ole Melkild, Wakeman Sound, for the sum of \$142.46.
Resolved:- "That the recommendation of the Treasurer be approved."
8. The Medical Health Officer submitted report for the month of April.
Resolved:- "That this report be received and filed."
Resolved:- "That Lease of Lots B and C Blk. 19, D.L. 82, to John Barnes be signed by the Commissioner, and that the Corporate Seal be affixed thereto."
Ordered:- "That accounts as under be approved for payment as and when funds are available:-
