

Wednesday - July 26th, 1933.

A Regular sitting of the Commissioner was held at the Municipal Hall on Wednesday July 26th, 1933 at 10 o'clock AM.

Present:- Commissioner Bennett and the Municipal Clerk.

Ordered: "That the minutes of the sitting of July 19th. be adopted as written and confirmed."

Correspondence was received and dealt with as follows:-

1. Messrs G. M. Grig, H. G. Rhodes and A. W. Dow wrote on behalf of the residents of Lochdale recommending the appointment of Mr. Frank Bingham as Caretaker at Lochdale Park on Elare Avenue.  
Ordered: "That this letter be tabled for further consideration."
2. T. H. Wilson requesting lease of Blk. 4, District Lot 136, for a period of five years.  
Ordered:- "That a lease of Blk. 4, D.L. 136 be granted to Mr. T. H. Wilson for a period of three years at a nominal rental of \$1.00 per year, plus taxes, the Lessee to carry out improvements to the extent of \$100.00 per annum.
3. J. A. Thurston wrote requesting permission to establish a shoe factory at the rear of Lot 7, Blks. 14, 15, 19, 20, D.L. 35.  
Ordered:- "That this application be referred to the Town Planning Commission for report and recommendation.

Messrs H. G. Stott and Charles Douglas wrote requesting permission to use Lot 12 E and W 1/2, S.D. 15, Bk. 15, 16, 11, S.C. 158E for the purpose of storing mill and bush wood.

Ordered:- "That permission be granted subject to the lot being kept in a neat and tidy condition, and further subject to a two weeks removal notice."
