

Wednesday, June 20th, 1934.

A Regular sitting of the Commissioner was held at the Municipal Hall on Wednesday, June 20th, 1934 at 10 o'clock a.m.
Present: Commissioner Fraser, Mr. R. Bolton and the Municipal Clerk.

Ordered: "That the minutes of the sitting of June 13th, be adopted as written and confirmed."

Correspondence was received and dealt with as follows:

1. Mrs. P. Sellers wrote advising he could not purchaser premises known as 3409 Barker Avenue on the terms as suggested by this Corporation, and requested to rent same at a monthly rental of \$20.00.
Ordered: "That this request be granted in accordance with the recommendation of the Treasurer that the premises above described be rented to Mr. P. Sellers at a rental of \$20.00 per month."

2. Fred Hall wrote requesting permission to put on an agriculture display at the forthcoming shows to be held at Vancouver and Victoria in the name of "Burnaby".
Ordered: "That the Clerk communicate with the Local Horticultural Assns. with a view to ascertaining whether or not they intend to put on a like exhibit, and that Mr. Hall be advised later."

3. Works Superintendent submitted recommendation re giving access to Block 63, District Lot 188, Canberra Street, at an estimated cost of \$90.00.
Ordered: "That this report be laid over."

4. Works Superintendent submitted report on giving access to property of Mr. C. Gray on Sprott Street at an estimated cost of \$50.00.
Ordered that access as recommended by the Works Superintendent be provided subject to payment of taxes by Mr. C. Gray.

Riddell & McIntosh Limited wrote offering to sell to the Corporation \$3000.00 5% District of Burnaby Bonds, due December 31st, 1938 issued under By-law No. 345. at a price of \$85.00

The Treasurer recommended that this offer be accepted.

5. Ordered: "That the recommendation of the Treasurer be and is hereby adopted."

Pemberton & Son wrote offering to sell to the Corporation \$1,000. District of Burnaby 5% Bond due November 26th, 1950 issued under By-law No. 90 at a price of \$60.00

The Treasurer recommended that this offer be accepted.

Ordered: "That the recommendation of the Treasurer be and is hereby adopted."

 corporate seal be affixed thereto."

Ordered: "That the Burnaby Land Sale By-law No. 3, 1934 be introduced and read a
 first time.

Ordered: "That the Burnaby Land Sale By-law No. 3, 1934 do pass the first reading.

Ordered: "That the Burnaby Land Sale By-law No. 3, 1934 be now read a second time.

Ordered: "That the Burnaby Land Sale By-law No. 3, 1934 do pass the second reading.

Mr. Robson attended and addressed the Commissioner requesting recognition of a
 Grievance Committee, and also took up several relief cases in which it was claimed
 the Relief recipient has been unable to obtain satisfaction.

The sitting then adjourned.
