

Wednesday - May 23rd. 1934.

A Regular sitting of the Commissioner was held at the Municipal Hall on Wednesday, May 23rd. 1934 at 10.00 a.m.

Present: Commissioner H.W. Fraser, Mr. R. Bolton and the Municipal Clerk.

Ordered: "That the minutes of the sitting of May 16th inst. be adopted as written and confirmed."

The Treasurer submitted recommendations that allowances be made under Section 274, as follows:

Ordered: "That the recommendations of the Treasurer be and are hereby adopted."

The Building Inspector submitted report on application of A & W Young to have the provisions of the Burnaby Town Planning By-law waived to permit of the operation of a Dairy on Lot 10, Block 6, D.L. 116/186, and recommended that the applicants be requested to support their application with the consent of adjacent property owners and residents.

Ordered: "That the report be received and the recommendation of the Building Inspector be and is hereby adopted."

The Clerk and Treasurer submitted recommendation that Mr. T.W. Turley be appointed caretaker of the Broadview Hall with remuneration as follows:

50 cents when Hall is rented for \$1.00  
 \$1.00 when hall is rented for \$2.50 and up.  
 .25 cents for extra hours.

The following scale of charges for the use of the Hall were also recommended:

Ratepayers Association Free to extent of 5 nights per month  
 Dances 8 to 12 (with piano) \$5.00 (\$1.00 for piano)  
 (without piano) \$4.00  
 Extra hours 50 cents.

Concerts (with piano) 7 to 11 \$2.50 for Hall \$1.00 for Piano.  
 (without piano) \$2.50 for Hall.

Badminton and Gym classes, etc. \$1.00  
 Afternoon meetings 2 to 5 \$1.00  
 Evening meetings to regular tenants \$1.00  
 Political meetings 7.30 to 11. \$5.00

Ordered: "That the recommendations of the Clerk and the Treasurer be and are hereby adopted."

The Building Inspector and Property Salesman submitted report on application of R. Wilson to purchase lumber in old garage situate on Lot 1, Block 9, D.L.27, and recommended that his offer of \$3.00 be accepted subject to the site being cleaned up to the satisfaction of an officer of the Corporation.  
 Ordered: "That the recommendation of the Building Inspector and the Property salesman be and is hereby adopted and that the Building Inspector be the officer of the corporation to see that the lot and site is properly cleaned up."

The Property Salesman submitted report on application of L.K. Hawkins to lease Lots 32, 33, 34 and 35, of D.L.86 for term of 5 years and recommended that a lease be granted at an annual rental equal to the amount of taxes accruing thereon.

Ordered: "That the recommendation of the Property Salesman be and is hereby adopted."

Ordered: "That A. B. Bell be and is hereby appointed Sanitary Inspector for the Corporation of the District of Burnaby."

General accounts \$25,329.90; Relief accounts \$1,731.77 and Pay Rolls \$2,219.20 were submitted for examination.

Ordered: "That General accounts, Relief Accounts and Pay rolls be approved for payment subject to funds being available."

The Requisitions were then examined.

Ordered: "That the requisitions as submitted be approved."

Ordered: "That the Burnaby Automatic Vending Machine By-law 1934 be introduced and read a first time."

Ordered: "That the Burnaby Automatic Vending Machine By-law 1934 do pass the first reading."

Ordered: "That the Burnaby Automatic Vending Machine By-law 1934 be now read a second time."

Ordered: "That the Burnaby Automatic Vending Machine By-law 1934 do pass the second reading."

The sitting then adjourned at 10.30 a.m.
