Moved by Cr.Hatherly, Seconded by Cr. Dingle: "That Richard Bolton, Tressurer, of the Corporation of the District of Burnaby be and is hereby authorized for and on behalf of the Corporation to negotiate with, deposit with or trans er to The Royal Bank of Canada (but for credit of the Corporation's account only) all or any cheques and other orders for the payment of money, and for the said purpose to endorse the same or any of them on behalf of the Corporation, either in writing or by rubber
