Raymer submitted application pursuent to the provisions of sub-section (b) of Paragraph (1) of the "Eurnaby Sale of Gasoline Regulation By-law 1936", being By-law No. 1547 of the Carporation of the District of Burnaby for a permit to remain open for the sale of gasoline during the twenty four hours of each and every lawful day, covering premises known and described as Oasis Service Station, 2635 Kingsway, Burnaby. Moved by Cr. Lewis, Seconded by Cr. West: "That the permit be granted." Carried unanimously.

Cr. Wilson reported verbally on the application of Messrs. Hecker and  $\mathcal{L}$ . Aver for Cabaret License for Green Gables and recommended that same be granted. Moved by Cr. Wilson, Seconded by Cr. West: That the report be accepted and the recommendation be adopted.

Carried unanimously.

Cr. Ball reported verbally on the application of E. Waldorf for a license to operate an engine repair shop at 5420 Smith Avenue and recommended that the Town Planning By-law be waived and the license be granted. Moved by Cr. Ball, Seconded by Cr. West: "That the report be accepted and the recommendation be adopted." 3. that

Cr.Lewis commented on the statements attributed to the Municipal clerk as appearing in the Ruesday August July sist issue of the Vancouver Daily Province and requested that the Clerk explain his remarks and why they were not made to the Council. The Clerk advised that the statements atbributed to him had not been made

for publication, but he outlined the procedure to be followed in the matter of sale of tax sale lands and gave it as his opinion that if the procedure as laid down in the Municipal Act were not adhered to the Council would be open to surcharge.
