

Monday - May 13th 1946

An adjourned meeting of the Council was held at the Municipal Hall, Edmonds on Monday, May 13th 1946 at 7:00 P.M.

Present: Reeve Morrison in the Chair, Crs. West, Philps, Beamish, Jones, Gartlan MacSorley and Ball.

Secretary, Burnaby School Board wrote requesting Council to set a date for the submission of extra-ordinary estimates, covering the cost of the drawing of plans and specifications for School Buildings in the 1946 programme.

Moved by Cr. Philps, Seconded by Cr. Beamish: "That the date set for receiving extra-ordinary estimates be May 20th 1946 at 7:30 P.M."

Carried Unanimously

E.H.Neville wrote submitted brief proposals for transportation system to cover certain areas in the Municipality together with rates which would be put into effect on these operations.

Moved by Cr. Ball, Seconded by Cr. Philps: "That the proposal be received and a date be set on which to meet Mr. Neville with his offer of a transportation system for the whole Municipality and that the same date be set for meeting Blue Line Transit Co. representatives."

Moved by Cr. Beamish, Seconded by Cr. Jones: "That the route as outlined in Mr. Neville's proposal be approved and that the Council meet Mr. Neville regarding plans to cover the whole Municipality and that the Blue Line Transit Co. representative be invited to meet the Council on the same date."
