Moved by Cr. West, Seconded by Cr. Philps: That the Minutes of the previous meeting be adopted as written and confirmed. Carried Unanimously.

Correspondence was received and dealt with as follows:-

F. Bingham wrote advising the Council to set a license fee for one cent target gun machine, which machine differentiates from a one cent vending machine in that it does not offer free games or prizes of any kind.

Moved by Cr. Beamish, Seconded by Cr. MacSorley: "That the letter be received and this matter be referred to a Special Committee of the Reeve, Cr. Philps and the Clerk for consideration and recommendation."

Carried Unanimously.

E.W. Arnott, B.C.E.R. Company, wrote with reference to the inauguration of bus service on Marine Drive and the extension of the 2nd Street bus service to 16th Avenue and Cumberland Road advising that the Company has committed itself to introduce a number of new services this year some of which require more units than originally contemplated and that no guarantee could be given to inaugurate the services requested until the equipment situation shows some relief.

Secretary, Public Utilities Commission, wrote advising that the matter of our request re extension of bus transportation is being investigated.

Moved by Cr. Philps, Seconded by Cr. Ball: That the letter be received and filed.

Minister of Public Works wrote with reference to laying of a concrete surface on the Douglas-Grandview Highway advising that it was not considered feasible to lay such a surface until the leaking water mains beneath the road were replaced by this Corporation and that it was their intention to lay a temporary surface on this section until the Corporation finds it possible to renew the water mains.
