Secretary, Burnaby School Board wrote requesting that the Council appoint a delegate to accompany a delegate from the School Board to Victoria for the purpose of interviewing the Minister of Municipality to determine whether or not the Department of Municipal Affairs, having regard to the present refunding plan in effect, would be in favour of and would sanction the submission of a By-law to the electorate of Burnaby for school building purposes, providing the Board of School Trustees and the Municipal Council decided to embark upon such a programme.
