

Tuesday - October 12th, 1948

An adjourned meeting of the Council was held at the Municipal Hall on Tuesday, October 12th, 1948 at 9:40 A.M.

Present: Cr. Philps in the Chair, Crs. West, Beamish, MacSorley, Gartlan, Drummond and McLean.

Moved by Cr. Beamish, Seconded by Cr. MacSorley: "That Reeve Morrison be granted Leave of Absence due to illness."

Carried Unanimously.

The Chief Commissioner of the Unemployment Insurance Commission wrote advising that by an amendment to the Unemployment Insurance Act a special order had been passed by the Commission resulting in a definition of the term "permanent employment" in so far as Municipal Employees are concerned, that is to say: Employment of a person by whom or for whose benefit contributions are made to an established superannuation, pension or retirement fund, or who has rights therein, but not of a person employed in the public service of Canada and to whom Part VI of the Civil Service Superannuation Act applies: and advising further that the following resolution is required to be passed by the Municipal Council in connection with the issuance of certificates of permanency "Resolved that for the purpose of certifying employment by The Corporation of the District of Burnaby as permanent in accordance with paragraph (1) of Part II of the First Schedule to the Unemployment Insurance Act and of special orders made by the Unemployment Insurance Commission thereunder the following be and they are hereby authorized to issue certificates Reeve and Clerk", and that certificates as laidout in Schedule A of the letter are to replace certificates now in force.

The Municipal Clerk submitted report on the letter received from the Unemployment Insurance Commission and recommended that the aforementioned resolution be passed by the Council.

Moved by Cr. Gartlan, Seconded by Cr. MacSorley: "That the reports be received and the recommendation of the Clerk be adopted with the signatures of the Reeve and Clerk amended to "Reeve and Treasurer."

Carried Unanimously.

Moved by Cr. Gartlan, Seconded by Cr. MacSorley: "That Burnaby Tax Sale Lands Monies Expenditure By-law No. 14, 1948 be now reconsidered."

Carried Unanimously.

Moved by Cr. Gartlan, Seconded by Cr. MacSorley: "That Burnaby Tax Sale Lands Monies Expenditure By-law No. 14, 1948 be now finally passed and that it be signed by the Reeve and Clerk and the Corporate Seal of the Corporation be affixed thereto"

Carried - Cr. West voting against.

Cr. Philps addressed the Council bringing to their attention the increased lack of recognition given to Burnaby by the Postal authorities pointing out that letters with "Burnaby" written as the point of destination are stamped by the authorities with the words "This address is served from the New Westminster Post Office, advise your correspondents to eliminate "Burnaby" from your address and substitute "New Westminster, B.C."

Moved by Cr. West, Seconded by Cr. MacSorley: "That a letter be forwarded to the Postmaster General and our two Members of Parliament objecting to the procedure adopted by the Postal authorities with regard to Burnaby addresses."

Carried Unanimously.

Cr. Philps reported verbally on the application of Messrs. J.J. Russell & R.A. Watt for a permit to erect and operate a Roller Rink on property located on the south side of Edmonds Street in the 600 Block recommending that the application be granted.

Moved by Cr. McLean, Seconded by Cr. MacSorley: "That the report be accepted and the recommendation of Cr. Philps be adopted."

Carried Unanimously.

The meeting then adjourned.
