Secretary, Southwest Burnaby Ratepayers Protective Assn. wrote with reference to applications for purchase of property at the corner of Alberta Ave. & Hurst St., and with particular reference to statement male to Chairman of the Property Committee by some person to the effect that the private individual applying to purchase this property intended to offer the property to the Ocean View Development Ltd., advising that this statement was entirely unfounded.

Letters of a similar nature were received from Joseph T. Mandy and Clarice E. Corble (one of the applicants.)

Property Manager suggested it would be good business to take advantage of the present brisk demand and explore ways and means of providing funds for the purpose of servicing certain areas, such costs to be included in the sale price of the property.
