Cr. McLean gave a verbal report on behalf of the committee appointed to combat the rlood menace in the Trapp Road area officials what had taken place in this connection in cooperation with army officials and with the aid of volunteer help.

MnoSorley: "That representatives of the Army be requested to meet with representatives of the residents and of the Council to discuss further measures to be taken with respect to the flood situation."

Reeve, Crs. McLean & MacSorley & Engineer were appointed to represent the Council.

The Reeve requested the Engineer to report on what took place during the week end June 5th and 6th when residents of the Municipality suffered an acute shortage of water due to a connection having been made by the Greater Vancouver Water listrict to a new 90" main from the Seymour Intake, without proper notification. The Engineer reported he was unaware the connection was to be made and that when the shortage first became aparent, he was unable to obtain any satisfaction from the Engineer of the Greater Vancouver Water District to relieve the situation in the first instance, but later obtained an additional water supply which afforded some relief. The Engineer requested that sprinkling regulations imposed during this emergency, be carried on until further notice.

Moved by Cr. Gartlan, Seconded by Cr. West: "That the request of the Engineer be senourred in and that sprinkling restrictions be advertised in the newspapers in order that enforcement orders may be made."
