Carried Unanimously

Moved by Cr. MacSorley, Seconded by Cr. Philps: "That Burnaby Land Acquisition & Street Dedication By-law No. 2, 1949 be now reconsidered."  
Carried Unanimously

Moved by Cr. MacSorley, Seconded by Cr. Philps: "That Burnaby Land Acquisition & Street Dedication By-law No. 2, 1949 be now finally adopted, that it be signed by the Reeve and Clerk and the Corporate Seal be affixed thereto."  
Carried Unanimously
