

Monday - February 28th 1949

An adjourned meeting of the Council was held at the Municipal Hall, Edmonton on Monday, February 28th 1949 at 9:45 A.M.

Present: Reeve Morrison in the Chair, Crs. Philps, Beamish, MacSorley, Gartlan, Stephens and Drummond.

Moved by Cr. Philps, Seconded by Cr. Gartlan: "That British Columbia Electric Company Limited Easement By-law, 1949 be now introduced, that the Council sit as a Committee of the Whole with the Reeve in the Chair to consider the By-law."

Carried Unanimously.

The Reeve then asked the question: "What is your pleasure with this By-law?" Moved by Cr. Philps, Seconded by Cr. Gartlan: "That the By-law be read by short title only."

Moved by Cr. Gartlan, Seconded by Cr. Philps: "That Burnaby Land Sale By-law No. 3, 1949 be now finally adopted, that it be signed by the Reeve and Clerk and the Corporate Seal be affixed thereto."

Secretary-Treasurer, Fraser Valley Municipal Association wrote advising that delegation from the Association will meet the Cabinet in Victoria on Friday, March 4th 1949 for the purpose of discussing the rising school costs in relation to their effect on Municipal budgets.

Moved by Cr. MacSorley, Seconded by Cr. Beamish: "That His Worship Reeve Morrison and the Municipal Clerk be authorized to attend as representatives of Burnaby Corporation."
