General Manager, Interprovincial Cooperatives Ltd. wrote advising they had acquired property described Lct "A", Block 22, D.L. 151/3 and that it was proposed to erect a building thereon, requesting permission to construct a spur track into the property for loading and unloading purposes, which track would be required to be either constructed on the unopened road allowance between Lot "A" and the B.C.E.R. right of way, or across a portion of Bonsor Park property and the end of Bonsor Avenue road allowance into the said Lot "A".

A representative of the Company attended and requested an interview.
