Charlton and MacSorley submitted report relative to an interview held with the Minister of Public Works to discuss matters pertaining to Hastings Street and Barnet Road, advising the Minister had signified he was prepared, at the request of this Corporation, to have a survey of the Hastings Barnet Road from Boundary Corporation, to have a survey of the Hastings Barnet Road from Boundary Road to Sperling Avenue, conducted to determine the eventual road allowance of this road, at a recommended 100° basis for right of way. On completion of the survey, the plans would be considered by both the Department and the Corporation, and if satisfactory to both parties, would be approved, and the Corporation would undertake to acquire the necessary additional road allowance, and when so acquired the Provincial Department of Public Works would undertake construction of the highway progressively. The Committee recommended that the Minister be officially requested to make the survey above mentioned requested to make the survey above mentioned. Moved by Cr. Armstrong, Seconded by Cr.
