Monday. June 15, 1953.

A regular meeting of the Municipal Council was held at the Municipal Hall, Edmonds, on Monday, June 15, 1953, at 7:30 p.m.

Present: Reeve Beamish in the Chair, Councillors Armstrong, Charlton, Drummond, Isherwood, MacSorley, Philps and Wilks.

Moved by Councillor MacSorley and seconded by Councillor Armstrong "That the minutes of the previous meeting be adopted as written, and confirmed."

Carried Unanimously.

H. C. Day wrote on behalf of the Quilchenna Golf Club making inquiries concerning the area within District Lot 137 in which their Club was interested for golf course purposes. The writer requested information as to whether or not the Council would consider leasing this land and on what terms.

Moved by Councillor Isherwood and seconded by Councillor Philps "That a committee of two be appointed to meet the applicants with a view to discussing their proposal further."

Carried Unanimously. The committee appointed included Councillors Jrummond and MacSorley.

Chief Engineer, Jepartment of Public Works wrote with reference to the installation of lighting standards along the south sile of Kingsway, drawing attention to a letter from the Department under date of March 19, 1949 wherein it was stated that the installation of lights on the south side of Kingsway would be held in abeyance pending the removal of overhead lines by the B. C. Telephone Company to an under-ground location. The Chief Engineer aivised that if the Company were prepared to remove their wires underground, the Jepartment would include sufficient monies in next year's estimates to take care of the work as previously promised. Moved by Councillor MacSorley and seconded by Councillor Isherwood That the letter be received and the B. C. Telephone Company be again requested for information as to the possibility of locating their wires underground.

Burnaby Parent-Teacher Council wrote further with regard to the installation of sidewalks on Marine Drive and Willington Avenue, stressing the need for these walks due to the importance of the two thoroughfares and the hazard existing to children and other pedestrians.

Moved by Councillor Isherwood and seconded by Councillor Wilks "That the letter be received and that the Parent-Teacher Council be informed the subject sidewalks can only be installed in accordance with the plan as aivised previously.
