Southern Slope Ratepayers' Association wrote requesting that attention be given to the repair of drains leading from the wading pool at McPherson Park and that public facilities be erected in the said Park, also request ing information as to the use the recently bulldozed land in Central Park between Boundary Road and the tram line was to be put. The Association also requested that the street lights at a number of intersections in the Southern Slope area on order with the B. C. E. R. be installed. The Council was asked also to set up a Parks Board.

Moved by Councillor Philps and seconded by Councillor MacSorley That the letter be received and the matters contained be referred to the Chairmen of the respective Committees concerned and the Engineer."

Carried Unanimously.

Little League Committee, South Burnaby Christian Men's Club submitted a request for improvement to Bonsor Park to facilitate use of the Park as a home base for the South Burnaby Little Baseball League. The Committee outlined the desired improvement including an outfield fence, bleachers, baseball backstop, regulation Little League baseball diamond, turfing of the playing grounds and a water outlet for drinking and sprinkling purposes. Your older Philps and seconded by Councillor MacSorley "That the application be received and referred to the Chairman of Parks and Planning Committee (Cr. Armstrong), Engineer and Clerk with Power to Act." Carried Unanimously.

Lower Mainland Park Advisory Committee wrote aivising a Bill was being introduced at the present Legislature to rescind the Garibaldi Park Act, which action conflicted with numerous resolutions of the Advisory Committee opposing such measures. The Committee submitted a brief prepared by the Garbaldi Park Board and addressed to the Minister of Lands and Forests outlining in detail reasons for its opposition to the rescinding of the Park Act.

Moved by Councillor Armstrong and seconded by Councillor Isherwood "That this matter be referred to a committee for study and report."

Carried Unanimously.
The committee appointed included Councillors Armstrong and Charlton.

B. C. Aviation Council submitted a bulletin on activities of their organization and requested payment of the annual \$10.00 membership fee. Moved by Councillor Charlton and seconded by Councillor Philps "That the communication be received and the membership fee be paid."

E. E. Winch, M.L.A. wrote advising a committee had been set up by the Legislature to consider the revision of riding boundaries and representation and that it was a general opinion that Eurnaby should be given dual representation resulting in the division of the riding into two parts, each with a single representative. The M.L.A. requested information as to what lines this division should take place.

Moved by Councillor Isherwood and seconded by Councillor Armstrong "That the letter be received and this matter be referred to a committee for report."

The committee appointed included Councillors Philps and Charlton.

Burnaby Ratepayers' Council submitted a protest against the high cost of domestic and combined sewers proposed to be installed through district Improvement By-laws affecting ratepayers in certain districts of the Municipality during the month of March. The Ratepayers' Council suggested that the costs were out of proportion with costs for similar work in the past. It was felt that the costs of surface drainage was the responsibility of the Municipality and that part of the cost of installing combined sewers should be borne by the Municipality out of general revenue.

Moved by Councillor Isherwood and seconded by Councillor MacSorley "That the letter be received and the Ratepayers' Council be advised that the appropriate Municipal officials would be willing to attend a meeting of their organization and explain the situation with regard to the cost of the sewers in question."

The Board suggested that the Council approve of a survey to be conducted by their Board to acquaint the various municipalities with a picture of some of the problems of growth which can be expected within the next decade and would attempt to describe Municipal and other agencies, their function, scope, authority and organization.

Moved by Councillor MacSorley and seconded by Councillor Charlton That the
letter be received and this matter be referred to a Committee of the Whole for further study.

Carried Unanimously.

Burnaby Girl Guide Association submitted an application for a financial grant for the year 1953. Moved by Councillor Philps and seconded by Councillor Isherwood "That the application be referred to the Committee on Grants."

Loyal Protestant Home for Children submitted application for permission to hold a Tag Jay on October 3, 1953.

The Association requested that the matter of surface drainage from the recently cleared area west of Tenth Avenue flowing on to private property be investigated. Thomas A. McGrath wrote with reference to his application to purchase land in District Lot 34 drawing attention to a letter from the Municipal Clerk under date of February 17th advising that he would be required to deposit \$15,550.00 for the installation of water mains along Willingdon Avenue and Moscrop Street, requesting that the Council accept the charge for installation of these mains and further that the School Board be charged with one-half the cost of the main to be installed on the perimeter roads of the school site.

Mr. McGrath appeared and requested an interview. Moved by Councillor Armstrong and seconded by Councillor Charlton "That Mr. McGrath be heard."

Mr. McGrath elaborated on the contents of his letter stressing that he considered it unfair that he should be expected to pay the full cost of the installation of the water mains in question as a charge on his project.
