Moved by Cr. W.P.Philps, seconded by Cr. Wilks "That "Burnaby General Borrowing and Hypothecation of Taxes By-law 1954" be now finally adopted, that it be signed by the Reeve and Clerk, and that the Corporate Seal be affixed thereto."
