(2) The westerly 33' of the property bordering Pioneer Street be dedicated for street widening purposes.

The Committee advised that the Provincial Government had agreed to pay two-thirds of the cost being \$4,777.00 and that the Hospital had submitted a cheque for \$7,000.00, requesting that the Corporation make a grant to the Hospital of \$2,333.33 which is equivalent to one-third of the sum inquestion. The Committee recommended that a grant be made on this basis and that the Treasurer be empowered to set up the Reserve and make thenecessary periodic investments as outlined in the report of the Committee dated 17th November.
