The Salvation Army submitted a request for an opportunity for their representative to be heard at the Council meeting. Their representative appeared. Brigadier J. T. Gillingham addressed the Council and requested a grant for the year 1954 on behalf of the Salvation Army. Moved by Councillor W.P. Philps, seconded by Councillor Charlton "That the matter be referred to the Committee on estimates."

Carried Unanimously.

The Ship-by-Rail Association was represented by a delegation, whose spokesman submitted a Brief concerning the damage done by trucking concerns to municipal roads.
Moved by Councillor W.P.Philps, seconded by Councillor Hean "That the brief be received and tabled for a period of two weeks.

Carried Unanimously.

The Auto Courts and Resorts Association wrote requesting that their Association be afforded an opportunity to have a delegate sit in on any Committee meetings of the Council where by-laws governing auto courts or any phase of their industry are being considered.

Moved by Councillor Charlton, seconded by Councillor F. Philps "That the letter be received and the Association notified when the Council meets to discuss auto court regulations."

Carried Unanimously.

Barry Mather submitted a letter of appreciation for the installation of a street light in the 3500 Block, Buckingham Avenue.

The Chief Engineer, Provincial Department of Public Works wrote advising that the current estimates for his Department did not include an item for street lighting on the south side of Kingsway.

Moved by Councillor F. Philps, seconded by Cr. W.P. Philps "That the letter be received and that the Department be again requested to include sufficient to cover this item in their current estimates. Carried Unanimously.

The PostMaster, New Westminster, submitted a letter of appreciation for the manner in which roads were cleared of snow in the Municipality making delivery easier during the recent snow-fall.
Moved by Councillor W.P.Philps, seconded by Councillor Hean "That the letter be received and filed."

Carried Unanimously.

B. C. Electric Railway Co. Limited wrote with reference to the Council's suggestion for the use of directional indicators on their busses at intersections, advising that their operators were being instructed to use the directional indicators so that no confusion would be caused or a hazard created in relation to other traffic at intersections where busses cross and pull into far side stops.

The Fraser Valley Municipal Associationsubmitted notice of the Annual General Meeting of the Association to be neld in the City Hall, New Westminster, Friday, February 12th.

Moved by Councillor W.P.Rhilps, seconded by Councillor Hughes "That the letter be received and the invitation be accepted by all who are able to attend.

Carried Unanimously.

E.E. Winch, M.L.A. wrote acknowledging Council's request for support to their proposal to the Government that sufficient funds be allowed in the current budget to permit a substantial increase in Social Allowances.
Moved by Councillor Morrison, seconded by Councillor Hughes "that the correspondence be received."

Carried Unanimously.

The Executive Assistant to the Premier wrote acknowledging Council's letter urging upon the Covernment that provision be made for increased Social Allowances.

Moved by Cr. Hughes, seconded by Cr. Hean "That the letter be received and filed."

Carried Unanimously.

The Sanitary Inspector submitted a report on the application of E. Matthews for permission to keep fifteen hogs on Lot "A", Block 26, D.L.40 advising that an inspection had found the area suitable for the keeping of not more than fifteen hogs for the period ending December 31st, 1954.

Moved by Cr. Morrison, seconded by Cr. F. Philps "That the report be received and the application be approved for a period ending December 31st, 1954." Carried Unanimously.

The Sanitary Inspector submitted a report on the application of A. &). Pittendrigh to keep poultry on Lot 5, S.). 7, 7, Block C pt,).L. 150, advising that upon inspection the property had been found suitable for the keeping of 30 chickens providing the existing chicken house was raised two feet from the ground.

Moved by Cr. Wilks, seconded by Cr. Charlton "That the report be received and the application approved, subject to the conditions as outlined in the refort." Carried Unanimously.

S/Sgt. Gerrie i/c Burnaby Detachment, P.C.M.P. submitted a report on the operations of that Department for the month of January.

Fire Chief, G. Waddell submitted a report on the operations of the Fire Departmen t for the month of January by Cr. Hughes "That the report be received."

Carried Unanimously.

The Municipal Engineer submitted a report on the suggestion of the North Fraser Harbour Commission that a lease of the water lot at the foot of Willard Avenue be taken out by the Corporation, recommending that this lease be entered into and that the Superior Shingle Mill be notified that their operations must not encroach on the foreshore. Moved by Councillor W.P.Philps, seconded by Councillor Hughes "That the recommendation of the Engineer be adopted."

Carried Unanimously.

The Municipal Engineer submitted a report on the proposal to increase garbage service, it would mean an estimated annual increase in operating cost from \$99,000.00 to \$148,000.00, plus an additional \$9,000.00 in maintenance of the dump. The Engineer reported that in addition it would be necessary to purchase four new collection units at a capital cost of \$5,000.00. It was further reported by the Engineer that the suggestion that increased service be provided only during the summer months could be accomplished by the use of hired trucks at an increased cost of approximately \$23,000.00, bringing the everall operating costs to \$122,000.00 as compared to \$148,000.00 for the complete weekly service. Moved by Cr. Charlton, seconded by Cr. Wilks "That the report be received and referred to the Committee on estimates." Carried Unanimously.

Moved by Cr. F. Philps, seconded by Cr. Hughes "That a notice be inserted in the two local newspapers and the British Columbian giving notification of the recent change in the manner of garbage collection.

Carried Unanimously.

The Burnsby Town Planning Commission submitted recommendation that the following applications for rezoning be approved:

Application of F.J.Russell for rezoning of Lots 22,23,24 and 25, Block 36, J.L.152 being known as 2832 Willingdon Avenue, from Residential to Light Industrial.

The Commission recommended that the following application for rezoning be not approved:

Co.Ltd. for re-zoning of Lots ("") and "E"; Block 18,).L.150 from residential to Local Commercial. The commission recommended that the application of the Burnaby School Board for reservation of the following lands for school purposes be approved:

D.L.129 - Lots 2 to 16 inc., north of Kitchener lane. Lots 30,31 and 32, north of Aubrey Street and Lots 2 to 8 inc. south of Curtis Street,

The Commission recommended that Section 9, sub-section (u) of the Eurnaby Town Planning by-law be amended To read as follows:

"Parking lot, when used in connection with Commercial premises thereto, for the use of customer parking or when used in conjunction with a business or use lawfully carried on within

said Residential zone."

The Commission reported having considered the Council's request that the Town Planning by-law be amended to include Golf Driving Ranges under Section 13 and recommended that the By-law remain as written. The Commission recommended that the Council set up a neighbourhood park site in the Parkcrest subdivision approximately kwamkykkwaxfamkxim 200 x 200 in area, in a central location.

Moved by Councillor Hughes, seconded by Councillor Wilks "That the recommendation re the park area in the Parkorest subdivision be adopted."

Carried Unanimously.

The Town Planning Commission submitted the following recommendations with regard to the regulations of trailer courts and auto courts:

The following is the recommendation contained in the report of the Special Committee dealing with the establishment of trailer courts: After ample discussion this Committee came to the considered opinion that Trailer Courts should be excluded from the Municipality of Burnaby. The Committee reasoned that it has been the experience of many American cities that Trailer Courts have been detrimental to the Community and the development of Trailer Courts has been ex-tremely hard to control. Many of these cities have now excluded, or are attempting to exclude trailer courts. In the iscussion it was pointed out that under present assessment conditions Trailer Courts impose an unfair burden on the school facilities of the Municipality.

2. The following are the recommendations contained in the report of the Special Committee dealing with the establishment of auto courts:

(a) The floor area of the living QUARTERS OF EACH AUTO court unit shall be not less than 400 square feet.

(b) Each Auto Court unit shall contain not less than the following plumbing fixtures - one water closet
one basin
one bathtub or shower
one sink for kitchen facilities.

(c) The number of Auto Court units on any site shall not exceed the number obtained by dividing the site area reckoned in square feet by 3,000, (fractions being needed); and provided no Auto Court shall be established on a site comprising of less than one-half acre of land.

(d) No more than two such Auto Court units shall beerected side by side in one building.
(e) Between each such Auto Court unit or each two such units, as described in (d) above, there shall be a parking space of not less than twenty feet width, either open or covered by a reof.
(f) Buildings of Auto Court units shall not exceed one storey in

height, except that two storeys are permissible in that one ouild-ing which contains the administration office and/or the private living quarters of the Auto Court operator.

(g) In each Auto Court parking accommodation for automobiles shall be

supplied in direct proportion to the number of Auto Court units.

(h) The depth of front, rear and side yards of every Auto Court shall be in accordance with the regulations applicable to the zone in which the Auto Court is located.

The following are the recommendations contained in the report of a Special Committee and a Committee of the Whole dealing with the establishment of Motels:

(a) The floor area of theliving quarters of each Motel unit shall be not less than 250 square feet.

(b) Each Motel unit shallcontain not less than the following plumbing fixtures: one water closet one basin one bathtub or shower.

- (c) The number of Motel units on any one site shall not exceed the number obtained by dividing the site area in square feet by 1500, provided that double the number of units so obtained may be permitted in a two storey building, but no Mctel building shall exceed two storeys.
- (i) No Motel shall be established on a parcel of land containing less than 20,000 square feet, nor having less than 133 feet abutting on the major street.
- (e) The depth of front, rear and sile ya rds of every Motel shall be

in accordance with the regulations applicable to the zone in which the

Matel is located. In each Motel public dining room facilities shall be provided in accordance with Burnaby Municipal Restaurant by-law 1954, but in no case (f) shall the area so allocated to dining room facilities contain an area of max ess than 400 square feet.
Cooking facilities shall not be provided in Motel units.

Moved by Councillor Wilks, seconded by Councillor Hughes "That the balance of the reports be tabled for a period of two weeks."

Carried Unanimously,

Councillor Charlton withdrew.

The Special Committee appointed to investigate conditions in the North Eurnaby sub office submitted a report advising that due to the dilapidated condition of the existing building, it would be advisable to not expend any appreciable sum of money in renovations. The Committee recommended the following:

- That this Municipality provide adequate funds to build and equip new quarters in North Rurnaby for theuse of the R.C.M.P., the Welfare Department and the Health Department.
- (2) That as the outlains of such a structure would enter several months work, it will be necessary to do some minor renovations to the present quarters so that the persons working there have at least reasonable con-

ditions in which to work.

(3) That the Municipal Department concerned bring down a report as to the length of time required to build such new quarters, and that such report be brought down as soon as possible.

(4) That dependent upon such above referred to report, the Municipality enter into a Lease for a length of time necessary to complete a new structure, with the owner of the present quarters in North Burnaby at \$100.00 per month.

For the information of the Council we would advise that the following properties are Municipally owned and might be available as a site on which to erect the above referred to building.

Lots 19 and 20, Block 7, J.L.116N.
This property contains 1200 square feet, and is located on Hastings Street at corner of Esmond Avenue. There is a building on Lot 19 which is occupied

by an Old Age Pensioner.
Lots 6 and 7, Plock "G",).L.127.
These are two large lots on the south side of Hastings Street halfway between lelta Avenue and Springer Avenue.

Lots 27, 28 and 29, Block 93,) L.122 and Lots 14 and 15, Block 9?,) L.1 These are five lots presently under reserve for the widehing of Hastings Street.

Confederation Park is also available.

Moved by Councillor Morrison, seconded by Councillor W.P.Philps "That Burnaby Property Exchange By-law No. 1, 1954" be now introduced and that the Council do sit as a Committee of the whole with the Reeve in the chair to consider the By-law."

Carried Unanimously. The Reeve asked the QUEStion "What is your pleasure with this By-Law?"

Moved by Councillor Morrison, seconded by Councillor W.P.Philps "That the By-law be read by short title only."

Moved by Councillor Morrison, seconded by Councillor Makkisanxxsaw.P. Philps "That the Committee do now rise and reroft the By-law complete without amendment."

Carried Unanimously.

The Council re-convened.
Moved by Councillor Morrison, seconded by Councillor w.P.Philps "That Burnaby Property Exchange By-law No.1, 1954" be now passed.

CarriedUnanimously.

The Municipal Clerk augressed one Council with reference to discussions hed with a representative of the community Programmes branch of the Department of Education, giving a resumee of the Work of the Programmes branch as follows:

The Branch was organized in the interests of recreation and was constituted to assist in an advisory capacity to public bodies interested in a program of recreation. Leadership training was available through the Branch and School Boards were being approached to operate night schools, the Branch to make grants in aid of local recreation commissions

schools, the Branch to make grants in aid of local recreation commissions towards salaries paid to regional Directors.

The Clerk advised it was necessary to appoint a local Recreation Commission in the Council's wisdom, and that if such commission were appointed, a representative would attend a five day conference in Victoria during the period February 22nd to 26th, expenses for which would be paid by the Department of Education.

Moved by Cr.F. Philps, seconded by Cr. Morrison "That His Worship Reeve MacSorley, and Councillors Hughes and Wilks be appointed to the local Recreation Commission for the Burnaby area, and that Councillor Wilks be delegated to attend the Victoria conference and that the difference in expenses between that paid by the Provincial Government and actual expenses be paid by the Corporation.

Carried Unanimously.



COMMITTEE OF THE WHOLE REPORT.

Your Committee met on February 8, and recommend that an application be made to the Provincial Government for an amendment to the Local Improvement Act Section 53, Paragraph 2 to provide that the basis of taxation under this section be on the assessed value of land or land and improvements.

Moved by Councillor W. Philps, seconded by Councillor F. Philps "That the recommendation of the Committee be adopted."

Carried Unanimously.
