A regular meeting of the Municipal Council was held at the Municipal Hall, 1930 Kingsway, on Monday, March 8th, 1954 at 7.30 p.m.

Present: Reeve MacSorley in Chair; Councillors W.P. Philps, Charlton, Wilks, Hughes. Hean. F. Philps and Morrison.

Rev. Bernard opened the meeting with prayer.

Moved by Cr. W.P.Philps, seconded by Cr. Hughes "That the minutes of the previous meeting be adopted as written and confirmed."

Carried Unanimously.

Southern Slope Ratepayers' Association wrote requesting an opportunity for a delegation to speak with regard to a condemned house on Portland Street, The delegation appeared.

Moved by Cr. Hean, seconded by Cr. Wilks "That the delegation be heard."

Carried Unanimously.

Mr. Myton spoke objecting to this houseand deploring thelack of action to have the building removed in spite of orders having been issued to either removate the building or have it removed.

Moved by Cr. Wilks, seconded by Cr. W.P.Philps "That the letter be received and the delegation thanked, and this matter be referred to the Building Inspector for report to Council."

Carried Unanimously.

Southern Slope Ratepayers' Association wrote requesting an interview with regard to the proposed golf driving range on Marine Drive. The delegation appeared by Cr. Hean, seconded by Cr. Hughes "That the delegation be headd."

Carried Unanimously.

Mr. W.Turner spoke re-iterating former objections radded by the Association and requesting that first, the Licence be refused for operation of the driving range; secondly, that the Council take steps to stop the work which is proceeding, and thirdly, that the lease of Lot 6 be refused.

E.R.Taylor Construction Company submitted conditions for renewal of their contract for operation of the Stride Avenue Gravel Pit.
A special Committeeof the Engineer and Chairman of the Board of Works and Water Works Committee submitted the following recommendations following up

the conditions of the Taylor Construction Company.

(1) The elimination of quotas now being supplied to the City of New Westminster, the Municipality of Richmond, and E.R. Taylor. Except for amounts up to 25 yards, no gravel would be supplied except for own use.

(2) The Corporation to take cover the despatching of trucks and the weighing of gravel. To this end it is recommended that a position of pit supervisor be created and boarded; One additional man may be necessary during

the peak season.

(3) The present surcharge on rehandling gravel from the stock pile be eliminated and the Corporation provide its own reloading facilities.

(4) The contractor be permitted to double shift during the summer months to

build up stock piles to our requirements.

(5) Stock piles of 1 128" crushed gravel be maintained at levels established by the Municipal Engineer. No further crushing of 22" material will be

required. (6) Permission should be granted to the Contractor to remove hardpan/burden from the top of the pit and sand from the floor of the pit without royalty charge. This material has no value to the corporation and constitutes a costly operation in uncovering of new gravel supplies.

(7) Any material sold, under the 25 yard limit will be in account with the Corporation, the cost to be set to include royalty, loading, overhead,

(8) Royalty charges to be removed on material used by the Corporation. This represents a book-keeping device whereby Board of Works jobs were charged 7 per ton (or \$17,000,00) in 1953) and the general revenue of the Corporation credited with the same amount.

(9) The rate to be paid to the Contractor for 1 1/8" crushed gravel under the foregoing conditions to be set at 63 cents per ton for the current year, run of back gravel to be supplied at 21 cents per ton.

(10) The Contractor be permitted to increase the cost of S.C.C asphalt mix by 15 cents per ton.

It will be necessary for the Corporation to rent or purchase the weighing facilities and office space now owned by E.P.Taylor, and to purchase or rent extra loading equipment as required. Moved by Cr. Hughes, seconded by Cr. F. Philps "That the report be tabled for a period of one week."

B.C.AviationCouncil sumibbted Minutes of the last executive meeting held December 8, 1953, and also requested payment of the 1954 annual dues amounting to \$10.00.

Moved by Cr. Morrison, seconded by Cr. Charlton "That the minutes be received and themembership fee be paid." Carried Unanimously.

The District of West Vancouver submitted a Brief outling West Vancouver's position with regard to the proposed extension of the P.G.E. railway. Moved by Cr. Hughes, seconded by Cr. Charlton "That the correspondence be received and filed."

. Carried Unanimously.

Burnaby Detachment, R.C.M.P. submitted a report on the complaint of street parking in the 2500 block Sussex Avenue in front of an apartment in this block and advising that repeated checks on this location revealed no major problem at this time. The Officer in charge reported, however, that surveil-

lance would be kept over the area and appropriate recommendations would be made if the need arose.

Moved by Cr. W.P.Philps, seconded by Cr. Charlton "That the report be accept received and the complainant notified of the contents of the report."

Carried Unanimously.

The Officer isc Burnaby Detachment, R.C.M.P. submitted a recommendation that consideration be given to the installation of parking meters at locations in the Municipality, referring particularly to Kingsway in the vicinity of the Simpson-Sears project and on Hastings Street within the shopping area.
Moved by Cr. Charlton, seconded by Cr. W.P.Philps "That the report be received and referred to the Traffic Committeefor further sady and recommendation."

Carried Unanimously.

The Officer i/c Burnaby Detachment, R.C.M.P. wrote with reference to the request for the removal of stop signs at intersecting streets along the Burnaby Lake tram line, advising that the B.C.E.R. Company had agreed to the removal of such signs and the matter would be considered in connection with the preparation of a new traffic by-law. Moved by Cr. Morrison, seconded by Cr. Wilks "That the report be received." Carried Unanimously.

The Officer i/o Burnaby Detachment, R.C.M.P. submitted a report with regard to the suggested installation of "stop" and 'go" lights at the intersections of Lougheed Highway and Sperling, and Hastings Street and Willingdon Avenue, recommending that as the volume of traffic entering these intersections was considered sufficient to warrant the installation of these lights, that application be made for their placement. Moved by Cr. Charlton, seconded by Cr. Morrison "That the report be received and the recommendation adopted."

Carried Unanimously.

The Sanitary Inspector submitted a report on the application of L. M.Munn to keep poultry on property at 6931 Winch Street, advising that the property had been found suitable for the keeping of hol more than 50 chickens, on Lot 93 E2 Map 1943, D.L.133. Moved by Cr. F.Philps, seconded by Cr. W.P.Philps "That the application be approved for the keeping of 50 chickens."

(a) That the streets crossed by the rail be returned to their original condition.

(b) That the line be constructed in such a way that no undue delay or de-

tour for public traffic will result.

(c) That the company take all necessary precautions to protect the public and this Corporation from damages arising out of the construction of the spur.

(d) That the Company or railroad (B.C.E.R.) agree to pay all costs in connection with any traffic warning device which may be found necessary in the future thereby relieving this Corporation of any future financial

(e) That the Company deposit with the Corporation the sum of \$100.00 representing the extra cost to the Corporation in connection with the forthcoming renewal of the John Street water main.

(2) That sewer connection fees be increased from \$40.00 to \$70.00 plus the additional fee of \$1.00 for inspection.

(3) That estimates of work covering the two-week period ended February 21st,1954 be approved as follows: Board of Works-General - \$41,925.00 water Works - General 13,775.00 Parks-General 2,900.00 Health & Sanitation-General 4,050.00

(4) That the Standard Oil Company be required to deposit the sum of \$38,750.00 to cover the cost of water service to their new site on Burrard Inlet and that as and when sales of Corporation-owned lands are made as a result of the installation of these services, the Company be reimbursed with the sum of \$6,850.00.

McAskill for rezoning of Lots 1 and 2, Block 35, D.L.30, from Residential to Commercial was approved, and it is a further recommendation of the Town Planning Commission that all property on the southeast side of Edmonds Stret for a depth of 120 feet, between Britton Street and the School Board property at 8th Street, be

rezoned from Residential to Commercial.

(5) That application of John L. Hudson for rezoning of Lot 8, Block 2,

D.L.173 from Residential to Local Commercial be not approved.

Moved by Cr. Hughes, seconded by Cr. W.P. Philps "That the recommendations of the Town Planning Commission be adopted." Carried Unanimously.

The Property Manager submitted a report on Property Sales for the months of January and February 1954. Moved by Cr. Morrison, seconded by Cr. Wilks "That the report be received."

Carried Unanimously.

The Chief Building Inspector submitted advice of the forthcoming 1954 Building officals conference to be held in Ottawa on April 5th and 6th at which time a discussion was to take place on the new National Building Code. The Inspector requested authority to aftend this conference in view of the proposed application of the National Building Code to the Municipal Building Code.

Moved by Cr. Morrison, seconded by Cr. Wilks "That the report be received and the Chief Building Inspector be authorized to attend this conference. Carried Unanimously.

The Apartment Committee submitted a report with respect to the erection of aparaments in the Municipality advising that while the newly instituted apartment regulations were helpfull for the orderly development of multiple family dwellings in the Municipality, they did noT go far enough. The Committee recommended that the matter be referred back to the Town Planning Commission with a view to setting up specific zones for this type of dwelling, the Committee, however, to assist the Commission in laying out such suggested zones.

Moved by Cr. Charlton, seconded by Cr. Morrison "That the recommendation of the Committee be adopted." Carried Unanimously.

The Special Committee appointed in connection with the revised method of garbage collection reported that the cost of making collections on the former plan on the basis of the same service over all the Municipality, would rise from the 1953 cost of \$90,000.00 to approximately \$97,000.00. On the other hand, if the new operation were continued in practice, the costs should decrease by approximately \$12,000.00. The Committee felt that the proposed operation change was warranted

for the following reasons:

(1) to provide uniformity of service throughout Burnaby.

(2) to take advantage of the worthwhile saving of \$19,000.00,

(3) this method of collection is in line with the practice in nearly all the surrounding communities, as well as the rest of the country.

Moved by Cr. W.PPWilps, seconded by Cr. Wilks "That the report be received and referred back to a Committee as a whole for further consideration."

Moved by Cr. Charlton, seconded by Cr. Wilks "That the Engineer be authorized to proceed with clearing the proposed works yard site with the use of current funds pending the passage of the Tax Sale Lands Monies By-law."

The Special Committee appointed to engage an architect to prepare plans for the alteration and erection of new wings in the Municipal Hall, reported having engaged Mr. K. Sandbrook, 338 1st Street, New Westminster, to prepare the said plans.

Moved by Cr. Hughes, seconded by Cr. Charlton "That the actions of the Committee be confirmed."

Carried, Councillor Wilks voting against.

Cr. Hean submitted a report on his Inquiries into the proposal to engage a full time solicitor, listing a number of reasons why it was necessary to make such an appointment and recommending the following:

(a) that this Municipality employ a full time solicitor and assistant solicitor.
(b) That the starting salary of such solicitor be not less than six thousand dollars (\$6,000.00) per year and that the starting salary of the assistant be not less than four thousand, eight hundred dollars (\$4,800.00)per year.

(c) That annual increments up to a maximum number of years be established.
(d) That the solicitor's position be advertised for as soon as possible.
(e) That upon a full time solicitor being employed, the job of assistant and stenographer be advertised.

(f) That such solicitor be authorized to prepare a statement as to costs of legal books and equipment required by his Department. (It is estimated that the costs of legal books and periodicals may amount to \$5,000.00 in the first instance and that once such a library is established it will be necessary to purchase replacement volumes, periodicals and new legal works from time to time.

Moved by Cr. W.P.Philps, seconded by Cr. Charlton "That the report be received and referred to the Committee on estimates." Carried Unanimously.

The application of N.J. Manson to lease Lot 6, Block 5, 0.L. 159 tabled from the last Council meeting was brought forward for further consideration. Mr. Turner of the Scuthern Slope Ratepayers' Association requested an opportunity to be heard. Mr. Turner spoke protesting the actions of the Council in dealing with this matter.

Moved by Cr. W.P.Philps, seconded by Cr. Hean "That Mr. Turner be not heard further in view of his failure to submit information additional to that already presented."

Carried Unanimously. Mrs. Brewer spoke requesting that the Council refuse the leasing of Lot 6, Moved by Cr. Morrison, seconded by Cr. F.Philps "That the application to lease Lot 6 be not entertained."

Carried Unanimously.
