DECEMBER 2, 1957

An adjourned meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4000 Grandview Highway on Monday, December 2, 1957 at 8.45 p.m.

"Burnaby Town Planning By-law 1948, Amendment By-law No.12, 1957" was laid on the table for consideration by Council.

Moved by Councillor Morrison, seconded by Councillor 7.P.Philps "That this By-law be tabled for one week."

Moved by Councillor F.Philps, seconded by Councillor Morrison "That leave be given to introduce "Burnaby Highway Exchange By-law No.5, 1957" and that it be now read a First Time."

Carried Unanimously.

Moved by Councillor F.Philps, seconded by Councillor Cafferky "That the by-law be read a Second Time."

Carried Unanimously.

Moved by Councillor F.Philps, seconded by Councillor Cafferky "That the Council go into Committee of the /bole to consider and report on the By-law." Carried Unanimously.

No one appeared with regard to the proposed By-law.

Moved by Councillor F.Philps, seconded by Councillor Morrison "That the Committee rise and report the By-law complete." Carried Unanimously.

Ellis Toppings and Olson Limited submitted an application to rezone Lot 3, Block "A" D.L.87 to Gasoline Service Station. Moved by Councillor Morrison, seconded by Councillor Hean "That the application be tabled pending receipt of reports from the Town Planning Commission and the Planning Engineer."

Mrs. M. James submitted a letter in connection with the Forest Glen Replotting scheme contending that the Corporation has been remiss in not fulfilling its obligations to the property owners involved in the scheme, setting out in detail her reasons therefor. Mrs. James requested that in order that the scheme may be completed in accordance with the proposal presented to the property owners and agreed to by them, the following procedures be followed:

(1) That the Highway created by the replotting be completed.

(2) That the Lots which reverted to the Corporation as a result of the replotting be sold.

be sold.

(3) That Grafton Street be completed in the manner proposed under the terms of the scheme.

(4) That whatever perimeter drainage system may be necessary to ensure that no lots in the scheme are rejected, be installed.

(5) That the service contract entered into in connection with the scheme be extended to one year after completion of the above work.

Moved by Councillor Hean, seconded by Councillor Morrison "That this matter be referred to the Planning Committee for investigation and report, and that the Chief Administrative Officer prepare answers to the questions raised by Mrs.James in her letter, for the Committee."

Carried Unanimously.

P. J. Reimbach wrote in connection with the construction of a sidewalk fronting his property advising that he had notified the Municipality of his need for two crossings and culverts and that he had been informed the charge for the two crossings and been constructed but only one culvert and that upon inquiring at the Municipal Hall was informed he would need to pay an additional \$32.00 for the culvert and crossing at the entrance to his driveway. Mr. Reimbach requested that since he had been misled in the matter that the additional culvert be installed in accordance with the original understanding, namely that the two sidewalk crossings and culverts be installed for the sum of \$15.00 each.
Moved by Councillor F.Philps, seconded by Councillor Brown "That the request of Mr. Reimbach be acceded to."

Carried Unanimously.

Burnaby Curling Club wrote requesting permission to remove a pile of earth from the site of their project opposite the Municipal Hall.
The Municipal Engineer submitted a report in connection with this request recommending that permission be granted to remove approximately one-half of the soil which is at present piled on the southerly boundary of the subject property.
Moved by Councillor Hean, seconded by Councillor Morrison "That the correspondence be received and permission granted to remove one-half of the soil in question."

Carried Unanimously.

South East Burnaby Ratepayers' Association submitted a letter requesting that the brush area bounded by Holmes and Wilberforce Streets, east of Cariboo Road be investigated with a view to eliminating the flooding and fire hazard and also reducing the potential danger to children in this area.

Moved by Councillor F.Philps, seconded by Councillor Brown "That the Municipal Engineer be requested to investigate the situation and submit his report thereon."

Carried Unanimously.

Edward Trotter submitted a letter requesting that Council initiate the development of a playground in the Stride Avenue area in order that the children in this area may be provided with facilities for recreational activities.

Moved by Councillor Hughes, seconded by Councillor Cafferky "That this matter be tabled pending a determination of the status quo of the park authorities and that once this has been established the matter be referred to the new authorities for consideration in the 1958 budget."

Carried Unanimously.

tando, Milsom and Frydenlund submitted a letter relative to an application of Mr. George Klein for a licence to operate an auto wrecking business at 5590 Douglas Road, requesting that since Council did not unanimously reject the licence application as required under the Municipal Act, and since his client will be required to invest a considerable sum of money towards improving the property for the contemplated operation, that confirmation be given by Council that the licence will in fact he issued in order that his client can commence development of the present fact be issued in order that his client can commence development of the property in compliance with Municipal regulations appurtenant thereto. Timber Preservers Limited submitted a letter in connection with the unemployment situation advising that their firm has been affected by these conditions and suggesting that a minimum amount of work be carried on by government bodies over the next few months which will have a beneficial effect of maintaining some stability in employment in firms such as theirs. Moved by Councillor Morrison, seconded by Councillor Hughes "That the correspondence be received."

Capitol Hill Ratepayers' Association wrote in connection with the Noxious Weeds Sapitol Hill Ratepayers' Association wrote in connection with the Noxious Weeds By-law advising that the members of their Association feel the by-law will create a hardship on many of the ratepayers in the Municipality in requiring them to maintain their boulevards and requesting that the by-law in question be rescinded. Moved by Councillor Hean, seconded by Councillor W.P.Philps "That the letter be received and the Ratepayers' Association be advised of the reasons why Council enacted this by-law."

S/Sgt. in Charge Burnaby Detachment RCMP submitted a letter requesting that the Municipality supply a third female stenographer to be employed in their CIB office.

Asst. Commr. Commanding "E" Division RCMP submitted a letter advising that the estimated cost of operating their Force within this Municipality commencing June 1, 1958 will be \$6,822.00 per man and that the cost to the Municipality will either be \$3,411.00 or \$5,117.00 per man per annum, based on 50 or 75% respectively, of the per capita cost.

Moved by Councillor Hughes, seconded by Councillor Morrison "That the correspondence be received."

Carried Unanimously.

A Brownjohn wrote relative to his inability to secure employment for his truck claiming that the treatment afforded him is both unfair and discriminatory and requesting that because he is a competent operator, that Council take definite and positive action on his behalf. The request of Mr. Brownjohn engendered some discussion concerning the truck hiring policy laid down by the Council in March of last year and it was brought to light that the Engineering Department is not adhering to this policy because it was found to be unworkable. The Municipal Engineer appeared and advised that he was in the process of preparing a report on this subject and that he expected to be able to lay it before Council very shortly. Mr.Brownjohn also appeared and requested the opportunity of addressing Council concerning his request Moved by Councillor F.Philps, seconded by Councillor Cafferky "That Mr. Brownjohn be heard." Carried Unanimously.

Mr. Brownjohn reiterated the statements made in his letter and added that he could produce even further evidence substantiating his allegations.

Moved by Councillor Morrison, seconded by Councillor Cafferky "That the recommendation of the Chief Sanitary Inspector be adopted." Carried Unanimously.

Special Committee submitted a report in connection with an application of the B. C. Association of the North American Baptists Incorporated for permission to operate an Old Peoples' Home at 1122 Government Road, advising that it is their opinion the property is not considered too large for the contemplated development, and that therefore on a strictly site area basis, would not recommend reduction of the size of this site. The Committee added that the subject property lies within that portion of the Government Road residential district which is under consideration at the moment for incorporation under a Community Plan and that the subject tract appears to be in conflict with the tentative proposals for the scheme in that over-all use of the subject property would frustrate road and subdivision development of adjoining parcels.
