#### MAY 20, 1958

A regular meeting of the Municipal Council was held in the Council Chambers, 4545 East Grandview-Douglas Highway, on Tuesday, May 20, 1958 at 7:30 p.m.

PRESENT:

Reeve Emmott in the Chair; Councillors McLean, Seifner, Mather, Jamieson, Brown and Wilson.

Moved by Councillor McLean, Seconded by Councillor Jamieson: "That minutes of the previous meeting be adopted as written and confirmed."

CARRIED UNANIMOUSLY

Mr. W. M. Manson, Sales Manager, B.C. Electric Railway Company attended as requested by the Council to explain the Company's proposed increases in street light, electric energy rates.

CARRIED UNANIMOUSLY

Mr. Manson advised that he was prepared to answer any queries that Council may have on overall street lighting electric rate increases. In answer to a query regarding the reasons for increased rates for providing street lighting electrical energy in view of the only labour costs involved being in the changing of lamps it was suggested by Mr. Manson that the increase was due to the ordinary spiraling of costs of providing street lighting service. It was submitted that the cost to the Company of a 4,000 lumen lamp was \$38.00 while the Corporation was paying at the present time \$33.50 and under the new rate pay \$36.84. A general discussion then ensued on the depreciation of plant and the numbers of incadescent lamps used in the Municipality together with other pertinent information dealing with the general operation of the Company in the Municipality.

Moved by Councillor McLean, Seconded by Councillor Jamieson: "That the spokesman be thanked for his attendance and presentation."

CARRIED UNANIMOUSLY

J. McGrath and others submitted a complaint that the drainage ditch in the 3700 Block Oxford Street required to be enclosed to eliminate a traffic hazard created by the narrowness of the roadway. Mr. McGrath appeared and requested an opportunity to speak on the matter.

Moved by Councillor Seifner, Seconded by Councillor Brown: "That Mr. McGrath be heard."  $\label{eq:moved}$ 

CARRIED UNANIMOUSLY

Mr. McGrath submitted that the original four inch tile along the street had been removed. It was submitted the four inch tile was too small and that advice had been received that an eight inch tile should be oinstalled. Advice had been received from the Engineering Department that the residents on the street would be required to pay for the larger tile. The spokesman asked that the Council authorize the installation and covering of the larger tile.

Moved by Councillor Wilson, Seconded by Councillor McLean: "That the original Motion be rescinded."

CARRIED UNANIMOUSLY

Moved by Councillor Seifner, Seconded by Councillor Brown: "That the Engineer be instructed to install a covered drain of adequate size in the subject block on Oxford Street."

CARRIED UNANIMOUSLY

Moved by Councillor Mather, Seconded by Councillor Jamieson: "That the spokesman be thanked for his attendance and presentation."

CARRIED UNANIMOUSLY.

W. J. Mattila wrote complaining that recent applications for water, sewer and building permits to enable a dwelling to be constructed at 7350 Pandora Street had been denied due to the inadequate water supply. Mr. Mattila appeared and requested an opportunity to address the Council.

Moved by Councillor Jamieson, Seconded by Councillor Wilson: "That Mr. Mattila be heard."

CARRIED UNANIMOUSLY.

Mr. Mattila elaborated on his complaint advising he was willing to pay the cost of extending the watermain to his property.

Moved by Councillor Wilson, Seconded by Councillor Seifner: "That Mr. Mattila be thanked for his attendance and presentation."

CARRIED UNANIMOUSLY.

Moved by Councillor Jamieson, Seconded by Councillor Brown: "That the question of water service in the 7300 Block Pandora Street and the immediately adjacent area be referred to a Committee of the Whole and a report on such services within the subject area be made available next Monday."

#### CARRIED UNANIMOUSLY.

The Brentwood Park Ratepayers' Association wrote requesting that existing arrangements for the installation of wooden street lighting standards in the Brentwood area be held in abeyance and that a study of ornamental street lighting be conducted as soon as possible.

Mr. Cloutier, President of the Association, appeared and requested an opportunity to address the Council.

Moved by Councillor McLean, Seconded by Councillor Seifner: "That Mr. Cloutier be heard."

### CARRIED UNANIMOUSLY.

Mr. Cloutier spoke elaborating on the points raised in the letter advising no protection was at present afforded women and children in the area. The spokesman requested that the Council arrange for adequate lighting before the winter season submitting that the people in the area were willing to pay their fair share.

It was reported to the Council that the entire matter of ornamental lighting in this area was under investigation at the present time.

Moved by Councillor Jamieson, Seconded by Councillor McLean: "That the letter be received and the spokesman be thanked for his presentation."

#### CARRIED UNANIMOUSLY.

Mr. M. Feldstein submitted an application for rezoning Lot 17, Block 3, D.L. 68 to Residential Multiple Family Zoning to allow his apartment development on adjacent property to be undertaken to better advantage.

CARRIED UNANIMOUSLY.

The Ladies Auxiliary, George Derby Health and Occupational Centre, submitted an invitation to the Council to attend an open house at the Centre on May  $2\delta th$ .

Moved by Councillor McLean, Seconded by Councillor Seifner: "That the invitation be received and accepted by those Councillors able to attend."

#### CARRIED UNANIMOUSLY.

The North Fraser Harbour Commissioners submitted an invitation to the Reeve and Councillors to participate in a tour of the North Arm Fraser River to

inspect the progress and development in the Harbour area on Saturday, May 31st from 9:00 a.m. to 12:00 Noon.

Moved by Councillor Brown, Seconded by Councillor Jamieson: "That the letter be received and the invitation accepted."

CARRIED UNANIMOUSLY.

G.W. Bruce Fraser, County Court Judge, submitted a letter of appreciation to the Reeve and Council for the privilege extended to him of using the Council Chambers for the recent Canadian Citizenship Ceremony.

Moved by Councillor McLean, Seconded by Councillor Jamieson: "That the letter be received."

CARRIED UNANIMOUSLY.

D. J. Hopkins wrote making application to the Council for installation of a stand pipe with tap near or on boulevard fronting their property at 7496 East Hastings Street.

Moved by Councillor Brown, Seconded by Councillor McLean: "That the letter be received and that the Hopkins' application be the subject of a report to the Council in Committee of the Whole next Monday."

CARRIED UNANIMOUSLY.

The Lozells Community Association wrote requesting that consideration be given by the Council to the permanent improvement of Greenwood Street, Phillips Avenue, and Brighton Street within the Lozells Community area.

Moved by Councillor Jamieson, Seconded by Councillor Brown: "That the letter be received."

CARRIED UNANIMOUSLY.

Graham B. Ladner, Barrister and Solicitor, wrote on behalf of his client, Mr. George A. Robertson in connection with a complaint against the J. C. Weins Construction Company in respect of the Company's operations on property at 4307 Grange Street. It was pointed out that the Council had previously investigated the operational nuisance and that to date there appeared to be no corrective measures taken.

A report was submitted to the Council verbally that the operation had been visited and found to be as alleged and that subsequently attempts had been made to locate other land in exchange. It was also reported that a meeting had been arranged between the Manager and principals of the Company to discuss the matter further.

Moved by Councillor Jamieson, Seconded by Councillor McLean: "That the letter be received and that this matter be tabled to next Monday night pending the submission of a report by the Municipal Manager."

The Municipality has now completed the purchase of these machines and has received the Bill of Sale which has been registered to place title in the name of the Municipality.

It is recommended that the form of release supplied by the Company be executed by the Reeve and Clerk, and the Corporate seal attached thereto.

It is recommended that Council authorize the acquisition of an easement from Bailey and Milliams Construction Co. Ltd. over the east five feet of Lot 10, Lot 13, of Blocks 1,2,3,4, and 6, D.L. 125, Group 1, NWD, Plan 18670, having a

frontage of five feet on the lane, Plan 18670, and extending to Buchanan Street by uniform width for the full depth of the said Lot 10. by the Municipality.

Moved by Councillor McLean, Seconded by Councillor Jamieson: "That authority be granted to the Reeve and Clerk to affix their signatures to an indenture of easement from Bailey and Williams Construction Co. Ltd. over the East five feet of Lot 10, Lot 13, of Blocks 1, 2,3,4 and 6, D.L. 125, Group 1, New Westminster District, Plan 18670, having a frontage of five feet on the Lane and extending to Buchanan Street by uniform width for the full depth of the said Lot 10 and that the Corporate Seal be affixed thereto."

# 14. British American Oil Company.

The Manager submitted a report on an application of the British American Oil Company to utilize a portion of the Trans-Mountain Oil Company pipe line easement to connect with an easement presently under negotiation. The Trans-Mountain Company have granted the British American Oil Company the right to use the portion of their right-of-way through a portion of D.L. 143 as shown on Plan deposited in the Land Registry Office at New Westminster, Numbered 13452. It was further reported the land covered by the easement is a .322 acre part of Block 1, D.L. 143 measuring approximately 300 feet long and 45 feet wide. The Solicitor was of the opinion that under terms of the Lease agreement entered into in April, 1953 approval of this Corporation is necessary as the easement granted to the Trans-Mountain Company the right to construct and maintain an oil pipe line for their own use only.

The Manager recommended approval be granted to the Trans-Mountain Company to permit the use of same by the British American Oil Company.

Moved by Councillor McLean, Seconded by Councillor Brown: "That the recommendation of the Manager be approved."

CARRIED UNANIMOUSLY.

## 15. Re: Proposed Replotting D.L. 86

The Manager submitted a resume of the history behind the above Replotting scheme for the information and at the direction of the Council.

Moved by Councillor Jamieson, Seconded by Councillor McLean: "That the report be received."

#### 16. Clean Contract - Municipal Hall.

The Manager reported on investigations made into the performance of cleaning services for the Municipal Buildings by Municipal Staff vs Contract cleaning submitting that the investigation had been conducted by co-operation with the maintenance supervisor, Burnaby School District, who reported services at the present were being provided in an extremely economical fashion and certainly more economical and trouble-free than a Municipally operated janitor system would be.

Moved by Councillor Brown, Seconded by Councillor Jamieson: "That the report be received and that the contract with Modern Building Cleaning Services be executed by the Reeve and Clerk and the Corporate Seal be affixed thereto."

CARRIED UNANIMOUSLY.

## 17. Re: Application to subdivide 89.3 feet of Lot 36, D.L. 132 - J. Derhousow.

The Manager reported on the history of the application made by Mr. Derhousow for subdivision of the subject property submitting details of the original application whereby Mr. Derhousow had been given tentative approval to subdivide by extending water service to the property via an easement over private lands and that since he had not taken advantage of this easement circumstances had changed which now required him to pay some Five Hundred Dollars to obtain the water service. It was submitted that Mr. Derhousow had requested permission to plead his case before the Council personally. It was recommended the application of Mr. Derhousow for exemption from the existing servicing regulations be denied. Mr. Derhousow appeared and requested

an opportunity to interview the Council.

Moved by Councillor Brown, Seconded by Councillor Seifner: "That Mr. Derhousow be heard."

CARRIED UNANIMOUSLY.

Mr. Derhousow reviewed the application as he understood it and suggested that personnel in the Planning Department had acted arbitrarily in that different regulations were submitted to him between the month of May in 1955 and the month of October in that year when at the latter time new servicing figures amounting to some \$4,000.00 were submitted to him.

Moved by Councillor Wilson, Seconded by Councillor Seifner: "That the report be received, that Mr. Derhousow be thanked and that he be assured the Council will give every consideration to his application with a view to disposing of the problem fairly.

Councillor Cafferky was appointed Chairman of the Committee, Councillors Seifner and McLean were appointed as members.

#### SAFETY COMMITTEE REPORT:

Your Committee met on Monday, May 12th and recommend:

That a policy be adopted whereby "no parking" areas be established in the vicinity of schools, the particular locations for which will be the subject

of a recommendation from the Traffic and Traffic Safety Committee from time to time.

- That the application of Donn Dean Collision Limited for permission to erect a directional sign in the triangle of land bounded by Kingsway, Merritt and Imperial Street, be rejected.
- 3. That traffic control measures as contained in paragraph 4 of the report of the Traffic and Traffic Safety Committee dated May 12, 1958, relative to the Grange Street-Patterson Avenue intersection be adopted.

Moved by Councillor Cafferky, Seconded by Councillor Jamieson: "That the recommendation of the Committee be adopted."

 ${\tt Mr.}$  Brown-john advised he was willing to reserve any comments he may have pending a review of the existing situation by the Municipal Manager together with any added information that may come forward.

His Worship, the Reeve addressed the Council with respect to the future financing of sewers in the Municipality submitting that the Sewer Board were somewhat concerned with the existing situation whereby that Board acted as financing agents for sewer works within the Municipality. It was submitted there was some dissention amongst the Board members at this practice and that while the Board was willing to finance the South Slope Sewer Area No. I project there was some speculation that they would rather not follow this practice in the future. It was suggested that the amendment to the Municipal Act be investigated whereby the Provincial Government would underwrite Municipal Bonds for loans of this type.

Moved by Councillor Jamieson, Seconded by Councillor Cafferky: "That the Reeve and the Manager and the Treasurer and Engineer investigate the various aspects of the new regulation involving the underwriting of loan debentures by the Provincial Government for sewer work in the Municipality."

CARRIED UNANIMOUSLY.
